

# EUROPEAN UNION CIVIL SERVICE TRIBUNAL

**Action brought on 26 June 2015 — ZZ v Commission****(Case F-92/15)**

(2015/C 294/100)

*Language of the case: French***Parties***Applicant:* ZZ (represented by: L. Levi and A. Tymen, lawyers)*Defendant:* European Commission**Subject-matter and description of the proceedings**

Action seeking annulment of both the decision to reassess the applicant's partial permanent invalidity rate and the decision partially rejecting the applicant's complaint, and claim for compensation for the material and non-material harm which the applicant claims to have suffered.

**Form of order sought**

The applicant claims that the Tribunal should:

- Annul the decision of 6 October 2014 to the extent that it fixes the applicant's partial permanent invalidity rate at only 68,5 %;
- annul the decision of 18 March 2015 partially rejecting the applicant's complaint of 13 January 2015;
- order the Commission to pay compensation for the financial loss suffered by the applicant;
- order the Commission to pay compensation for the non-material harm suffered by the applicant, assessed at EUR 110 000;
- order the Commission to pay the costs in their entirety.

**Action brought on 30 June 2015 — ZZ v EEAS****(Case F-94/15)**

*Language of the case: French***Parties***Applicant:* ZZ (represented by: S. Orlandi and T. Martin, lawyers)*Defendant:* European External Action Service (EEAS)**Subject-matter and description of the proceedings**

Annulment of the decision rejecting the applicant's questioning the result of the EEAS Staff Committee elections.

**Form of order sought**

The applicant claims that the Tribunal should:

- Annul the appointing authority's decision of 23 April 2015 validating the EEAS Staff Committee elections, the result of which was published on 17 March 2015;
- order the EEAS to pay the costs.

**Action brought on 1 July 2015 — ZZ v Commission**

**(Case F-95/15)**

*Language of the case: French*

**Parties**

*Applicant:* ZZ (represented by: S. Orlandi and T. Martin, lawyers)

*Defendant:* European Commission

**Subject-matter and description of the proceedings**

The annulment of the final decision on the transfer of the applicant's pension rights to the European Union pension scheme, which applies the new general implementing provisions of 3 March 2011 for Article 11(2) of Annex VIII to the Staff Regulations.

**Form of order sought**

The applicant claims that the Tribunal should:

- declare illegal Article 9 of the general implementing provisions for Article 11(2) of Annex VIII to the Staff Regulations;
- annul the decision of 6 November 2014 confirming the transfer of the pension rights acquired by the applicant prior to entering the service under the general implementing provisions of 3 March 2011 for Article 11(2) of Annex VIII to the Staff Regulations;
- order the European Commission to pay the costs.

**Action brought on 1 July 2015 — ZZ v Commission**

**(Case F-96/15)**

*Language of the case: French*

**Parties**

*Applicant:* ZZ (represented by: S. Orlandi and T. Martin, lawyers)

*Defendant:* European Commission

**Subject-matter and description of the proceedings**

Annulment of the proposal to transfer the pension rights of the applicant into the European Union pension scheme, which applies the new general implementing provisions of Article 11(2) of Annex VIII to the Staff Regulations, and the request that the defendant be ordered to pay a provisional advance of one euro in respect of the loss allegedly suffered by the applicant.
