## **INTRODUCTION**

This document aims at providing a comprehensive overview of the logic that has been used to allocate CELEX numbers since the setting-up of the EUR-Lex database (formerly known as CELEX).

All CELEX sectors have been thoroughly analysed and the study results can be found in a table which explains the allocation of numbers by sector.

The table indicates the descriptors used for each type of act and contains examples, specifically for documents published in OJ-L, OJ-C or directly on EUR-Lex. In addition to this information, an introductory note in each section of the table indicates the general rules used to allocate CELEX numbers by sector.

Three sectors (0, 7 and C) are not listed in the tables but, for completeness, specific remarks about them have been included.

## 1. General rules

CELEX numbers can be based on different information:

### (i) **Date of publication**

The CELEX numbers are based on the **date of publication of the Official Journal**. Different acts published on the same day bear the same number, with the only difference of a specific split number. If only one act of the same type is published in OJ, the CELEX contains split number (01).

### (ii) **Internal number**

Different numbers assigned by the authors (COM numbers, JOIN numbers, ECB numbers, Case number, etc.).

### (iii) **Official Number (PPF = Print Production File number)**

Sequential numbers attributed to documents at the moment of their publication in OJ assigned by the Publications Office.

#### *Examples*

Council Decision **(EU) 2015/3** ...

Council Decision **(CFSP) 2015/4** ...

Commission Delegated Regulation **(EU) 2015/5** ...

Commission Implementing Directive **(EU) 2015/6** ...

Decision **(EU) 2015/7** of the European Parliament ...

Decision **(EU, Euratom) 2015/8** of the European Parliament ...

### *Special cases*

(a) The following documents are originally unnumbered:

- international agreements and information on the date of their entry into force; their corrigenda

(b) Some documents have two numbers — **a number assigned by the Publications Office** at the moment of their publication in the OJ (PPF) and a number previously assigned by the author, e.g.:

- ECB legal acts and instruments, e.g. Decision **(EU) 2015/33** of the European Central Bank ... (ECB/2015/1)
- Political and Security Committee decisions, e.g. Political and Security Committee Decision **(CFSP) 2015/258** ... (EUBAM Libya/1/2015)

In other cases, the number assigned by the Publications Office to the following documents does not contain the domain element (EU; CFSP; etc.) and is placed at the end of the title in square brackets:

- acts adopted by bodies created by international agreements: Decision No 2/2015 of the ACP–EU Committee of Ambassadors ... **[2015/45]**
- acts adopted within the framework of the European Economic Area (EEA): Decision of the EEA Joint Committee No 58/2015 ... **[2015/100]**
- acts adopted within the framework of the European Free Trade Association (EFTA): Decision of the EFTA Surveillance Authority No 02/10/COL ... **[2015/101]**
- regulations of the United Nations Economic Commission for Europe (UN/ECE): Regulation No 28 of the Economic Commission for Europe of the United Nations (UN/ECE) ... **[2015/46]**

In these two special cases, the Celex number is based on either the date of publication, the number assigned by the Publications Office (PPF) or the internal number assigned by the authors (see detail on the tables for each sector).

## **2. Corrigenda**

All documents (except from sectors 0 and 7) may have one or more corrigenda.

Corrigenda are published in both the L and C series of the Official Journal. The CELEX number of a corrigendum is based on the same number as that of the CELEX number of the document being corrected followed by the letter R and a sequential number between brackets.

The CELEX number for the first corrigendum of a given act would thus receive the suffix R(01), the second R(02), and so on, according to chronological order.

Please note that, since July 2013, it may happen that a corrigendum has different bibliographical data for different linguistic versions (e.g. different pagination due to the different extent of the linguistic versions, that can correct different points of the original act), featuring however the same CELEX number (with suffix R(01), R(02)...). The reason for this is that, as from July 2013, corrigenda to an act that are published in the same OJ have the same CELEX number, regardless of the fact that their bibliographical data may be different.

Note as well that a given document may not necessarily have been corrected in all official languages of the European Union and, consequently, a corrigendum may not be available in all languages.

### 3. CELEX numbers by sector

#### 3.1. SECTOR 0: CONSOLIDATED LEGISLATION

Consolidated texts are non-official documents usually integrating acts of Sector 3 with their amendments and corrections.

Their CELEX numbers are composed of **0** (indicating the current sector) + **the CELEX number of the consolidated act** (without the first number which indicates its initial sector) + **the date of application of the last amending act**.


Example: **01999L0094-20031120**: Directive 1999/94/EC of the European Parliament and of the Council of 13 December 1999 relating to the availability of consumer information on fuel economy and CO<sub>2</sub> emissions in respect of the marketing of new passenger cars.

### 3.2. SECTOR 1: TREATIES

The treaties are available in EUR-Lex. There is usually a separate notice for the complete text, a separate notice for preamble, a separate notice for final act, a separate notice for each article of the treaty or of the final act (but not of protocols, annexes or declarations), a separate notice for each protocol, declaration and annex. These separate documentary items have a **three-digit number**. Annexes, declarations, protocols, etc. are given ad hoc references that are, in fact, abbreviations divided by slashes.

The general rules for creation of the CELEX numbers are:

### 3.8. SECTOR 7: NATIONAL TRANSPOSITION MEASURES

The CELEX numbers for national transposition measures are composed as follows:

- The first digit represents the CELEX sector, which is 7 for national transposition measures;
- Similarly to CELEX numbers of legal acts belonging to Sector 3 the following eight characters give information on the legal act that is being implemented. The first four digits represent the year, the letter indicates the type of act and the following four digits represent its unique number;
- After this, there is a three letter country code, indicating the Member State which is the author of the given national transposition measure;
- After an underscore, there is a new number, being the unique identifier from the database of the Secretariat-General of the Commission.
