

**PROVÁDĚCÍ ROZHODNUTÍ KOMISE (EU) 2017/2175****ze dne 21. listopadu 2017,****kterým se mění příloha prováděcího rozhodnutí (EU) 2017/247 o ochranných opatřeních v souvislosti s ohnisky vysoce patogenní influenza ptáků v určitých členských státech***(oznámeno pod číslem C(2017) 7835)***(Text s významem pro EHP)**

EVROPSKÁ KOMISE,

s ohledem na Smlouvu o fungování Evropské unie,

s ohledem na směrnici Rady 89/662/EHS ze dne 11. prosince 1989 o veterinárních kontrolách v obchodu uvnitř Společenství s cílem dotvoření vnitřního trhu <sup>(1)</sup>, a zejména na čl. 9 odst. 4 uvedené směrnice,s ohledem na směrnici Rady 90/425/EHS ze dne 26. června 1990 o veterinárních a zootechnických kontrolách v obchodu s některými živými zvířaty a produkty uvnitř Společenství s cílem dotvoření vnitřního trhu <sup>(2)</sup>, a zejména na čl. 10 odst. 4 uvedené směrnice,

vzhledem k těmto důvodům:

- (1) Prováděcí rozhodnutí Komise (EU) 2017/247 <sup>(3)</sup> bylo přijato v návaznosti na výskyt ohnisek vysoce patogenní influenza ptáků podtypu H5 v řadě členských států (dále jen „dotčené členské státy“) a vymezení ochranných pásem a pásem dozoru příslušným orgánem dotčených členských států v souladu s čl. 16 odst. 1 směrnice Rady 2005/94/ES <sup>(4)</sup>.
- (2) Prováděcí rozhodnutí (EU) 2017/247 stanoví, že ochranná pásma a pásma dozoru vymezená příslušnými orgány dotčených členských států v souladu se směrnicí 2005/94/ES mají zahrnovat přinejmenším oblasti uvedené jako ochranná pásma a pásma dozoru v příloze uvedeného prováděcího rozhodnutí. Prováděcí rozhodnutí (EU) 2017/247 dále stanoví, že opatření, která mají být uplatňována v ochranných pásmech a pásmech dozoru, jak je stanoveno v čl. 29 odst. 1 a článku 31 směrnice 2005/94/ES, mají být zachována alespoň do dat stanovených pro tato pásma v příloze uvedeného prováděcího rozhodnutí.
- (3) Od data přijetí prováděcího rozhodnutí (EU) 2017/247 bylo uvedené rozhodnutí několikrát změněno, aby byl zohledněn vývoj epizootologické situace v Unii, pokud jde o influenzu ptáků. Prováděcí rozhodnutí (EU) 2017/247 bylo konkrétně změněno prováděcím rozhodnutím Komise (EU) 2017/696 <sup>(5)</sup> s cílem stanovit pravidla pro odesílání zásilek jednodenních kuřat z oblastí uvedených v příloze prováděcího rozhodnutí (EU) 2017/247. Uvedená změna zohlednila skutečnost, že jednodenní kuřata představují ve srovnání s jinými drůbežními komoditami jen velmi nízké riziko šíření vysoce patogenní influenza ptáků.
- (4) Prováděcí rozhodnutí (EU) 2017/247 bylo následně rovněž změněno prováděcím rozhodnutím Komise (EU) 2017/1841 <sup>(6)</sup>, aby se posílila opatření pro tlumení nákazy použitelná v případech, kdy existuje zvýšené riziko šíření vysoce patogenní influenza ptáků. V důsledku toho nyní prováděcí rozhodnutí (EU) 2017/247 stanoví, že v návaznosti na ohnisko nebo ohniska vysoce patogenní influenza ptáků se na úrovni Unie vymezí další uzavřená pásma v dotčených členských státech, jak jsou uvedena v čl. 16 odst. 4 směrnice 2005/94/ES, a dobu platnosti opatření, která v nich mají být uplatňována. Prováděcí rozhodnutí (EU) 2017/247 nyní rovněž stanoví pravidla pro odesílání živé drůbeže, jednodenních kuřat a násadových vajec z těchto dalších uzavřených pásem do jiných členských států, s výhradou splnění určitých podmínek.

- (5) Kromě toho byla mnohokrát změněna příloha prováděcího rozhodnutí (EU) 2017/247, zejména aby se zohlednily změny hranic ochranných pásem a pásem dozoru vymezených dotčenými členskými státy v souladu se směrnicí 2005/94/ES. Příloha prováděcího rozhodnutí (EU) 2017/247 byla naposledy změněna prováděcím rozhodnutím Komise (EU) 2017/2000<sup>(1)</sup>, a to v návaznosti na oznámení Itálie o nových ohniscích vysoce patogenní influenza ptáků podtypu H5N8 v hospodářstvích s chovem drůbeže v regionu Lombardie uvedeného členského státu. Itálie také oznámila Komisi, že v návaznosti na uvedená ohniska přijala nezbytná opatření požadovaná podle směrnice 2005/94/ES, včetně vymezení ochranných pásem a pásem dozoru kolem nakažených hospodářství s chovem drůbeže.
- (6) Od data poslední změny prováděcího rozhodnutí (EU) 2017/247 prováděcím rozhodnutím (EU) 2017/2000 oznámilo Bulharsko Komisi dvě nová ohniska vysoce patogenní influenza ptáků podtypu H5N8 v hospodářstvích s chovem drůbeže v regionech Sliven a Jambol uvedeného členského státu. Bulharsko také oznámilo Komisi, že v návaznosti na uvedená nová ohniska přijalo nezbytná opatření požadovaná podle směrnice 2005/94/ES, včetně vymezení ochranných pásem a pásem dozoru kolem všech nakažených hospodářství s chovem drůbeže.
- (7) Kromě toho Itálie oznámila Komisi další ohniska vysoce patogenní influenza ptáků podtypu H5N8 v hospodářstvích s chovem drůbeže, která se nacházejí v regionech Lombardie, Piemonte a Lazio uvedeného členského státu. Itálie také oznámila Komisi, že v návaznosti na uvedená nová ohniska přijala nezbytná opatření požadovaná podle směrnice 2005/94/ES, včetně vymezení ochranných pásem a pásem dozoru kolem všech nakažených hospodářství s chovem drůbeže a rozšíření vymezených dalších uzavřených pásem.
- (8) Komise prozkoumala opatření, jež Bulharsko a Itálie přijaly v návaznosti na nedávná ohniska vysoce patogenní influenza ptáků v uvedených členských státech v souladu se směrnicí 2005/94/ES, a přesvědčila se, že hranice ochranných pásem a pásem dozoru, které vymezily příslušné orgány uvedených dvou členských států, jsou v dostatečné vzdálenosti od všech hospodářství s chovem drůbeže, kde byla ohniska vysoce patogenní influenza ptáků podtypu H5N8 potvrzena. Komise rovněž prozkoumala hranice dalších uzavřených pásem, která vymezil příslušný orgán v Itálii v souvislosti s nedávnými ohnisky v uvedeném členském státě, a přesvědčila se, že rozloha oblastí, na které se rozšíření uvedených dalších uzavřených pásem vztahuje, je s ohledem na stávající epizootologickou situaci v Itálii dostatečná.
- (9) Aby se předešlo jakémukoli zbytečnému narušení obchodu uvnitř Unie a kladení neopodstatněných překážek obchodu ze strany třetích zemí, je nutné na úrovni Unie a ve spolupráci s Bulharskem a Itálií urychleně popsat ochranná pásma a pásma dozoru vymezená v uvedených dvou členských státech a rozšířená další uzavřená pásma vymezená v Itálii v souladu se směrnicí 2005/94/ES v návaznosti na nedávná ohniska vysoce patogenní influenza ptáků v uvedených členských státech. Položky týkající se Bulharska a Itálie v příloze prováděcího rozhodnutí (EU) 2017/247 by proto měly být aktualizovány, aby zohledňovaly aktuální epizootologickou situaci v uvedených členských státech, pokud jde o uvedenou nákazu. Do seznamů v příloze prováděcího rozhodnutí (EU) 2017/247 je zejména zapotřebí doplnit nové položky pro ochranná pásma a pásma dozoru v Bulharsku a Itálii a pro rozšířená další uzavřená pásma v Itálii, která jsou nyní předmětem omezení v souladu se směrnicí 2005/94/ES.
- (10) Příloha prováděcího rozhodnutí (EU) 2017/247 by proto měla být za účelem aktualizace regionalizace na úrovni Unie změněna tak, aby zahrnovala ochranná pásma a pásma dozoru vymezená v Bulharsku a Itálii a rozšířená další uzavřená pásma vymezená v Itálii v souladu se směrnicí 2005/94/ES v návaznosti na nedávná ohniska vysoce patogenní influenza ptáků v uvedených členských státech a dobu trvání omezení, která mají být v těchto pásmech uplatňována.
- (11) Prováděcí rozhodnutí (EU) 2017/247 by proto mělo být odpovídajícím způsobem změněno.
- (12) Opatření stanovená tímto rozhodnutím jsou v souladu se stanoviskem Stálého výboru pro rostliny, zvířata, potraviny a krmiva,
