On 2 June 2014, the Commission decided not to oppose the above notified concentration and to declare it compatible with the internal market. This decision is based on Article 6(1)(b) of Council Regulation (EC) No 139/2004⁽¹⁾. The full text of the decision is available only in the German language and will be made public after it is cleared of any business secrets it may contain. It will be available:
