# Judgment of the General Court (Second Chamber) of 12 March 2019 – France v Commission

(Case T-26/18)

(EAGF and EAFRD — Expenditure excluded from financing — Expenditure incurred by France — One-off and flat-rate financial corrections — Area-related aid scheme — Land Parcel Identification System — Determination of eligible areas — Maintenance of agricultural land in good agricultural and environmental condition — Landscape features — Grazable heathland — National monitoring system based on a non-compliant definition of eligible areas — Proportionality — Obligation to state reasons — Conformity Clearance — Most likely error — Error of law)
