COMMISSION REGULATION (EC) No 564/1999

of 16 March 1999

establishing the standard import values for determining the entry price of certain fruit and vegetables

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Commission Regulation (EC) No 3223/94 of 21 December 1994 on detailed rules for the application of the import arrangements for fruit and vegetables (1), as last amended by Regulation (EC) No 1498/98 (2), and in particular Article 4 (1) thereof,

Whereas Regulation (EC) No 3223/94 lays down, pursuant to the outcome of the Uruguay Round multilateral trade negotiations, the criteria whereby the Commission fixes the standard values for imports from third countries, in respect of the products and periods stipulated in the Annex thereto;

Whereas, in compliance with the above criteria, the standard import values must be fixed at the levels set out in the Annex to this Regulation,

HAS ADOPTED THIS REGULATION:

Article 1

The standard import values referred to in Article 4 of Regulation (EC) No 3223/94 shall be fixed as indicated in the Annex hereto.

Article 2

This Regulation shall enter into force on 17 March 1999.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

COMMISSION REGULATION (EC) No 565/1999

of 16 March 1999

fixing the export refunds on beef and veal and amending Regulation (EEC) No 3846/87 establishing an agricultural product nomenclature for export refunds

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organisation of the market in beef and veal (1), as last amended by Regulation (EC) No 1633/98 (2), and in particular Article 13 thereof,

Whereas Article 13 of Regulation (EEC) No 805/68 provides that the difference between prices on the world market for the products listed in Article 1 of that Regulation and prices for those products within the Community may be covered by an export refund;

Whereas Regulation (EEC) No 32/82 (3), as last amended by Regulation (EC) No 2326/97 (4), Regulation (EEC) No 1964/82 (5), as last amended by Regulation (EC) No 2469/ 97 (6), and Regulation (EEC) No 2388/84 (7), as last amended by Regulation (EEC) No 3661/92 (8), lay down the conditions for granting special export refunds on certain cuts of beef and veal and certain preserved beef and veal products;

Whereas it follows from applying those rules and criteria to the foreseeable situation on the market in beef and veal that the refund should be as set out below:

Whereas, given the current market situation in the Community and the possibilities of disposal in certain third countries in particular, export refunds should be granted, on the one hand, on bovine animals intended for slaughter of a live weight greater than 220 kilograms and less than 300 kilograms, and, on the other on adult bovine animals of a live weight of at least 300 kilograms;

Whereas export refunds should be granted for certain destinations on some fresh or chilled meat listed in the Annex under CN code 0201, on some frozen meat listed in the Annex under CN code 0202, on some meat or offal

listed in the Annex under CN code 0206 and on some other prepared or preserved meat or offal listed in the Annex under CN code 1602 50 10;

Whereas, in view of the wide differences in products covered by CN codes 0201 20 90 700 and 0202 20 90 100 used for refund purposes, refunds should only be granted on cuts in which the weight of bone does not exceed one third;

Whereas, in the case of meat of bovine animals, boned or boneless, salted and dried, there are traditional trade flows to Switzerland; whereas, to allow this trade to continue, the refund should be set to cover the difference between prices on the Swiss market and export prices in the Member States; whereas there are possibilities for exporting such meat and also salted, smoked and dried meat to certain African, Near and Middle Eastern countries; whereas a refund should accordingly be set;

Whereas, in the case of certain other cuts and preserves of meat or offal shown in the Annex under CN codes 1602 50 31 to 1602 50 80, the Community share of international trade may be maintained by granting a refund corresponding to that at present available;

Whereas, in the case of other beef and veal products, a refund need not be fixed since the Community's share of world trade is not significant;

Whereas Commission Regulation (EEC) No 3846/87 (9), as last amended by Regulation (EC) No 381/1999 (10), establishes an agricultural product nomenclature for export refunds; whereas for the sake of clarification the conditions to be satisfied as regards the average lean-meat content of boneless cuts should be specified;

Whereas, in order to simplify customs export formalities for operators, the refunds on all frozen cuts should be brought into line with those on fresh or chilled cuts other than those from adult male bovine animals;

Whereas experience has shown that in certain cases it is often difficult to determine the relevant quantities of beef, veal and other meat contained in prepared or preserved meat falling within CN code 1602 50; whereas exclusively beef and veal products should accordingly be set apart and a new heading should be created for mixtures of meats or offals; whereas checks on products other than mixtures of meat or offal should be stepped up by making the granting of refunds on these products conditional on manufacture under the arrangements provided for in Article 4 of Council Regulation (EEC) No 565/80 of 4 March 1980 on the advance payment of export refunds in respect of agricultural products (¹), as amended by Regulation (EEC) No 2026/83 (²);

Whereas refunds on female animals should vary depending on their age in order to prevent abuses in the export of certain pure-bred breeding animals;

Whereas opportunities exist for the export to certain third countries of heifers other than those intended for slaughter, but to prevent any abuse control criteria should be laid down to ensure that these animals are not more than 36 months old;

Whereas, notwithstanding the subdivision of the Combined Nomenclature for prepared and preserved meat, other than uncooked, falling within CN code 1602 50, experience has shown that it is possible to delete from the refund nomenclature several products falling within CN code 1602 50 31 and to amend the list of products falling within CN code 1602 50 80;

Whereas the Management Committee for Beef and Veal has not delivered an opinion within the time limit set by its chairman,

HAS ADOPTED THIS REGULATION:

Article 1

1. The list of products on which export refunds as referred to in Article 13 of Regulation (EEC) No 805/68 are granted and the amount thereof shall be as set out in Annex I to this Regulation.

2. The destinations are identified in Annex II to this Regulation.

Article 2

The grant of the refund for product code 0102 90 59 9000 of the nomenclature for export refunds and for exports to the third countries in zone 10 listed in Annex II to this Regulation shall be subject to presentation, when the customs formalities for export are completed, of the original and one copy of the veterinary certificate signed by an official veterinarian certifying that these are heifers of an age of not more than 36 months. The original of the certificate shall be returned to the exporter and the copy, certified as being in accordance with the regulations by the customs authorities, shall be attached to the application for payment of the refund.

Article 3

Footnote (6) in Sector 5 of the Annex to Regulation (EEC) No 3846/87 is replaced by the following:

'The lean bovine meat content excluding fat is determined in accordance with the procedure described in the Annex to Commission Regulation (EEC) No 2429/86 (OJ L 210, 1.8.1986, p. 39).

The term "average content" refers to the sample quantity as defined in Article 2(1) of Regulation (EC) No 2457/97 (OJ L 340, 11.12.1997, p. 29). The sample is to be taken from that part of the consignment presenting the highest risk'.

Article 4

This Regulation shall enter into force on 17 March 1999.

This Regulation shall be binding in its entirety and directly applicable in all Member States.

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Whereas Commission Regulation (EC) No 1839/95 of 26 July 1995 laying down detailed rules for the application of tariff quotas for imports of maize and sorghum into Spain and imports of maize into Portugal (3), as amended by Regulation (EC) No 1963/95 (4), lays down the rules governing the administration of those special arrangements; whereas this Regulation lays down the special additional detailed rules necessary for implementing the invitation to tender, in particular those relating to the lodging and release of the security to be lodged by operators to ensure compliance with their obligations and, in particular, the obligation to process or use the imported product on the Spanish market;

Whereas in the light of current market needs in Spain, an invitation to tender for the reduction in the duty on imports of maize should be opened in the framework of these special arrangements for imports;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

- 1. An invitation to tender is hereby opened for the reduction in the import duty referred to in Article 10(2) of Regulation (EEC) No 1766/92 on maize to be imported into Spain.
- The invitation to tender shall be open until 27 May 1999. During that period, weekly invitations shall be issued with quantities and closing dates as shown in the notice of invitation to tender.
- Regulation (EC) No 1839/95 shall apply save as otherwise provided for in this Regulation.

Article 2

Import licences issued under these invitations to tender shall be valid 50 days from the date they are issued, within the meaning of Article 10(4) of Regulation (EC) No 1839/95.

Article 3

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

Article 1(1) of Regulation (EC) No 2007/98 is hereby amended as follows:

A special intervention measure in the form of an export refund shall be implemented in respect of 550 000 tonnes of oats produced in Finland and Sweden and intended for export from Finland and Sweden to all third countries.

Whereas the operative events for the aid referred to in Article 16(3)(d) of Commission Regulation (EC) No 2571/ 97 on the sale of butter at reduced prices and the granting of aid for cream, butter and concentrated butter for use in the manufacture of pastry products, ice-cream and other foodstuffs (4), as last amended by Regulation (EC) No 494/ 1999 (5), are defined in points 4A (i), (ii) and (iii) of part B.III of the Annex to Regulation (EEC) No 1756/93; whereas the increase introduced by Commission Regulation (EC) No 1061/98 (6) in the tendering security referred to in Article 17(1) of Regulation (EC) No 2571/97 implies that the economic aim is achieved at the moment of tender and thus the dates mentioned above must be replaced by the final date on which tenders for a particular invitation to tender are to be submitted;

THE COMMISSION OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 822/87 of 16 March 1987 on the common organisation of the market in wine (1), as last amended by Regulation (EC) No 1627/98 (2), and in particular Article 38(5) thereof,

Whereas Commission Regulation (EC) No 2486/98 (3), as last amended by Regulation (EC) No 520/1999 (4), introduces preventive distillation as provided for in Article 38 of Regulation (EEC) No 822/87;

Whereas, after the final date for the submission of contracts, it was found that there were still limited quantities of wine unsuitable for the market but adversely affecting it in the Charentes region of France as a result of the continuing crisis in the cognac sector and in Italy; whereas, under the circumstances, those wines should be withdrawn from the market by reintroducing preventive distillation for a limited volume with a view to improving the quality of the wines that should remain on the market;

Whereas, where the overall volume exceeds the quantities provided for, Member States must apply a single rate of reduction to all new contracts submitted;

Whereas, with a view to the sound management of the quantities in question, it is necessary to derogate from certain provisions of Commission Regulation (EEC) No 2721/88 of 31 August 1988 laying down detailed rules for voluntary distillation as provided for in Articles 38, 41 and 42 of Regulation (EEC) No 822/87 (5), as last amended by Regulation (EEC) No 2181/91 (6), and to provide that the quantities applied for in the contracts and declarations may be reduced;

Whereas, to improve the effectiveness of the measure, distillation should take place over a short timescale and the Member States should be permitted to impose more restrictive measures, in particular the introduction of a security to accompany the submission of the contract or declaration;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Wine,

HAS ADOPTED THIS REGULATION:

Article 1

In Regulation (EC) No 2486/98 the following Article 1 a is added:

'Article 1a

- Preventive distillation of table wine and wine suitable for yielding table wine as referred to in Article 38 of Regulation (EEC) No 822/87 is reintroduced for the 1998/99 wine year in the region of Charentes in France and in Italy for quantities restricted to 50 000 hl and 500 000 hl respectively.
- All producers who have produced table wine or wine suitable for yielding table wine may, by 16 April 1999 at the latest, sign a preventive distillation contract or declaration with the competent authorities of the Member State for a quantity restricted to 20 hl per hectare, specifying in particular:
- (a) the surname, forename and address of the applicant;
- (b) the quantity of the wine he has produced and wishes to distil in accordance with the Community rules on the quality of the products to be delivered for distillation;
- (c) the name and address or company name of the distillery.

The distillation contract or declaration shall be accompanied by a copy of the production declaration submitted to the competent authorities for the 1998/ 99 wine year.

Applicants shall also provide proof that they hold the wine in question. The Member States may limit the number of distillation contracts that a producer may sign under this Article.

The Member States shall establish the reduction rate to be applied to the above contracts and declarations if the total quantity exceeds the quantity established. They shall take the administrative measures

- 4. Deliveries to the distilleries must be made by 30 July 1999 at the latest.
- 5. The Member States may stipulate that the contract or declaration be accompanied by proof that
- a security has been lodged as provided for in Article 1(3).
- 6. Regulation (EEC) No 2721/88 shall apply, except for Article 6(1) and (4).

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.

Having regard to the Treaty establishing the European Community,

Having regard to Council Directive 89/556/EEC of 25 September 1989 on animal health conditions governing intra-Community trade in and imports from third countries of embryos of domestic animals of the bovine species (1), as last amended by the Act of Accession of Austria, Finland and Sweden, and in particular Article 8 thereof.

Whereas Commission Decision 92/452/EEC (2), as last amended by Decision 97/249/EC (3), establishes a list of embryo collection teams and embryo production teams approved in third countries for the export of embryos of domestic animals of the bovine species to the Community;

Whereas the competent veterinary services of Australia, Canada and the United States of America have forwarded requests for amendments to the lists of teams officially approved in their territories for the export of embryos of domestic animals of the bovine species to the Community; whereas it is therefore necessary to amend the list of approved teams; whereas guarantees regarding compliance with the requirements specified in Article 8 of Directive 89/556/EEC have been received by the Commission;

Whereas the list of approved collection and production teams in the Annex to Decision 92/452/EEC has been amended several times; whereas therefore it is appropriate to consolidate this list, taking account of the modifications made since the adoption of this decision;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Standing Veterinary Committee,

HAS ADOPTED THIS DECISION:

Article 1

The embryo collection and production teams listed in the Annex are hereby approved for the export to the Community of embryos of domestic animals of the bovine species.

Article 2

The Annex of Decision 92/452/EEC is replaced by the Annex to this Decision.

COMMISSION DECISION

of 26 February 1999

establishing ecological criteria for the award of the Community eco-label to personal computers

(notified under document number C(1999) 425)

(Text with EEA relevance)

(1999/205/EC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 880/92 of 23 March 1992 on a Community eco-label award scheme (1), and in particular the second subparagraph of Article 5(1) thereof,

Whereas the first subparagraph of Article 5(1) of Regulation (EEC) No 880/92 provides that the conditions for the award of the Community eco-label shall be defined by product groups;

Whereas Article 10(2) of Regulation (EEC) No 880/92 states that the environmental performance of a product shall be assessed by reference to the specific criteria for product groups;

Whereas the Community is negotiating an agreement on the coordination of energy labelling, based on the US 'Energy Star' programme;

Whereas it is appropriate to revise the criteria within a period of two years in order to adapt the energy requirements to technological innovation, market developments and the abovementioned 'Energy Star' programme;

Whereas in accordance with Article 6 of Regulation (EEC) No 880/92 the Commission has consulted the principal interest groups within a consultation forum;

Whereas the measures provided for in this Decision are in accordance with the opinion of the Committee set up pursuant to Article 7 of Regulation (EEC) No 880/92,

HAS ADOPTED THIS DECISION:

Article 1

The product group 'personal computers' (hereinafter referred to as 'the product group') shall mean:

'commercially available stationary computers consisting of a monitor, system unit and keyboard.'

Article 2

The environmental performance and the fitness for use of the product group shall be assessed by reference to the specific ecological criteria set out in the Annex to this Decision.

Article 3

The definition of the product group and the specific ecological criteria for the product group shall be valid for a period of two years from the first day of the month following the adoption of the criteria. If revised ecological criteria have not been adopted before the end of this period, their validity shall be extended for a further year.

Article 4

For administrative purposes the code number assigned to this product group shall be '013'.

Article 5

This Decision is addressed to the Member States.

ANNEX

FRAMEWORK

In order to be awarded an eco-label, the personal computer shall comply with the criteria of this Annex, which are aimed at promoting:

- the reduction of environmental damage or risks related to the use of energy (global warming, acidification, depletion of non-renewable resources) by reducing energy consumption,
- the reduction of environmental damage related to the use of natural resources by encouraging upgradability, recyclability and maintainability of the computer.

Additionally, the criteria encourage the implementation of best practice and enhance the environmental awareness of consumers.

Furthermore, the marking of plastic components encourages their recycling.

KEY CRITERIA

1. Energy savings: monitor

The monitor shall have a sleep mode power consumption of ≤ 10 watts.

The monitor shall have a deep-sleep mode power consumption of ≤ 3 watts.

The default mode-change time from operation to sleep and from sleep to deep-sleep shall be ≤ 30 minutes of inactivity. The manufacturer must enable this feature, but the user may disable it.

2. Energy savings: control unit

The control unit shall have a sleep mode power consumption of \leq 27 watts. This applies to the control unit when it is not in network operation (i.e. stand-alone mode).

The default mode-change time from operation to sleep shall be ≤ 30 minutes of inactivity. The manufacturer must enable this feature, but the user may disable it.

The off-mode power consumption shall be no more than 5 watts.

3. Life-time extension

The manufacturer shall offer a commercial guarantee to ensure that the system unit and keyboard will function for at least three years, and that the monitor will function for at least one year. This guarantee shall be valid from the date of delivery to the customer. The availability of compatible replacement parts and service shall be guaranteed for five years from the time of shipment.

In addition, the personal computer shall meet the following criteria:

- 1. the system unit shall have a modular design, allowing components to be easily accessible;
- 2. the system unit shall be accessible with commonly available tools, facilitating the exchanging of components;
- 3. upgradability shall be ensured for at least the processor, the graphics card, the random access memory, the hard disk and, if available, the CD-ROM drive;
- 4. one or more empty slots shall be available.

BEST PRACTICE CRITERIA

4. Take-back and recycling

The manufacturer shall guarantee the take-back of the personal computer and of components being replaced, except for items contaminated by users (e.g. in medical or nuclear applications).

In addition, the personal computer shall meet the following criteria:

- 1. one trained person, alone, shall be able to dismantle the system unit;
- 2. the manufacturer shall check the disassembly of the system unit and provide a disassembly report. Amongst others, the report shall confirm that joints are:
 - easy to find and accessible,
 - as standardised as possible,
 - accessible with all-purpose tools;
- 3. incompatible and hazardous materials shall be separable;
- 4. 90 % of plastic and metal materials in the housing and chassis shall be recyclable;
- 5. if labels are required, they shall be easily separable or inherent;
- 6. plastic parts shall:
 - (a) have no lead or cadmium added by the manufacturer;
 - (b) be of one polymer or compatible polymers, except for the cover which shall consist of no more than 2 types of polymer which are separable;
 - (c) contain no metal inlays that cannot be separated;
- 7. plastic parts heavier than 25 grams shall:
 - (a) not contain flame retardants that contain organically bound bromine or chlorine;
 - (b) have a permanent marking identifying the material, in conformity with ISO 11469. Excluded from this criterion are extruded plastic materials.

5. User instructions

The personal computer shall be sold with an instruction manual, which provides advice on the correct environmental use and, in particular:

- 1. recommendations for the use of the power management features, including information that disabling these features can lead to higher consumption of energy and thus can increase the running costs;
- 2. information on the maximum and minimum energy use of the system unit and monitor during operation, sleep, deep-sleep and off modes, as well as an indication that the energy use can be reduced to zero if the computer is unplugged or if the wall socket is switched off;
- 3. information on the guarantee and the availability of spare parts;
- 4. information on how to access the system unit and exchange components, specifically the processor, the graphics card, the random access memory, the hard disk and, if available, the CD-ROM drive;
- information about those parts and materials of the personal computer which are reusable and/or recyclable;
- 6. advice on how the consumer can make use of the manufacturers' take-back guarantee.

6. Environmental declaration

An environmental declaration shall accompany the product and shall be available to the user. This document shall be in conformity with the recommendations of ECMA's Technical Report 70 'Product-related environmental attributes'.

TESTING

7. Testing laboratories

If testing is required, it shall be performed at the expense of the applicant by laboratories that meet the general requirements stressed in the standards EN 45001.

CONSUMER INFORMATION

The following text shall be provided in such a way as to be clearly visible for consumers (next to the label, whenever possible):

- This product qualifies for the European Union eco-label, because it is efficient with energy and is designed to facilitate upgrading, recycling and environmentally sound disposal.
- Additional information on how to minimise environmental impacts is given in the instruction manual.
