2. Orders the parties to bear their own costs.

Judgment of the Civil Service Tribunal of 13 December 2007 — N v Commission of the European Communities

(Staff case — Temporary agents — Recruitment — Post of head of administration — Non-member country — Unfavourable opinion of the medical service)

Parties

Applicant: N (Brussels) (originally represented by K.H. Hagenaar, lawyer, then by J. van Drooghenbroeck and T. Demasure, lawyers, and finally by I. Kletzlen, lawyer)

Defendant: Commission of the European Communities (represented by: J. Currall and K. Herrmann, Agents)

Re:

Annulment of the Commission's decision not to recruit the applicant as a temporary agent to the post of head of administration in Guinea Conakry as a result of the unfavourable opinion of the medical service and a claim for damages

Operative part of the judgment

The Tribunal:

1. Annuls the decision of the Director of Directorate K 'External service' of Directorate-General 'External Relations' of the Commission of the European Communities of 15 April 2005, informing the applicant that she would not be recruited as head of administration of the delegation in Guinea;
2. Dismisses the remainder of the action;
3. Orders the Commission of the European Communities to pay the costs.
