

EUROPEAN UNION CIVIL SERVICE TRIBUNAL

Action brought on 29 January 2013 — ZZ v Commission**(Case F-9/13)**

(2013/C 215/28)

*Language of the case: Italian***Parties***Applicant:* ZZ (represented by: G. Cipressa, lawyer)*Defendant:* European Commission**Subject-matter and description of the proceedings**

Application for annulment of the Commission's decision to set off the sum corresponding to the costs it was ordered to pay by the General Court in Case T-176/04 against the sum which the applicant is required to pay pursuant to the order in Case T-241/03.

Form of order sought

- Annul the note of 6 March 2012;
- Annul the decision to effect recovery by offsetting the debt of EUR 1 600 owed by the Commission to the applicant against the sum of EUR 4 875 purportedly owed by the applicant to the Commission, which is denied;
- Annul, in so far as necessary, the decision rejecting the complaint lodged on 23 June 2012 sent by the applicant to the Commission and received by the latter at a date not later than 23 June 2012;
- Annul the note of 27 August 2012 received by the applicant on 9 October 2012,
- Order the Commission to reimburse the applicant in respect of all the costs incurred in the present proceedings.

Action brought on 22 May 2013 — ZZ v Council**(Case F-49/13)**

*Language of the case: French***Parties***Applicant:* ZZ (represented by: T. Bontinck and A. Guillerme, lawyers)*Defendant:* Council of the European Union**Subject-matter and description of the proceedings**

Annulment of the decision not to take into consideration the application submitted by the applicant for a position available at the Council.

Form of order sought

The applicant claims that the Tribunal should:

- annul the decision of 17 January 2013 by the mobility department of the GSC refusing to take into consideration the application submitted by the applicant for position 2244 DGA 2A, confirmed, following the applicant's complaint, by the mobility department's decision of 12 February 2013;
- order the Council of the European Union to pay the costs.

Action brought on 27 May 2013 — ZZ v EEAS**(Case F-53/13)**

*Language of the case: French***Parties***Applicant:* ZZ (represented by: S. Orlandi, J.-N. Louis and Abreu Caldas, lawyers)*Defendant:* European External Action Service**Subject-matter and description of the proceedings**

Annulment of the decision not to promote the applicant to Grade AD12 in the 2012 promotion procedure.

Form of order sought

The applicant claims that the Tribunal should:

- annul the appointing authority's decision not to promote the applicant to Grade AD12 in the 2012 promotion procedure;
 - order the EEAS to pay the costs.
