Notice concerning undertakings offered in connection with the anti-dumping proceeding concerning imports of citric acid originating in the People's Republic of China: change of the address of a company

(2012/C 74/10)

The undertakings offered in the framework of an anti-dumping proceeding concerning imports of citric acid originating in the People's Republic of China were accepted by Commission Decision 2008/899/EC ⁽¹⁾.

RZBC Imp. & Exp., a sales company located in the People's Republic of China which is related to the producers RZBC Co. Ltd and RZBC (Juxian) Co. Ltd, whose undertaking was accepted by Decision 2008/899/EC, has informed the Commission that on 26 November 2010 it changed its address to No 66, Lvzhou South Road, Rizhao (Liangyou Grand View Hotel, 22nd Floor, Building A), Shandong Province, PRC.

The company has argued that the change of address does not affect the right of the company to benefit from the terms of the undertaking accepted under its previous address.

The Commission has examined the information provided and has concluded that the change of address in no way affects the findings of Decision 2008/899/EC. Therefore, the references, in Article 1 of Decision 2008/899/EC to

RZBC Imp. & Exp. Co., Ltd — No 9, Xinghai West Road, Rizhao, Shandong Province

should be read as
