Notice for the attention of the person subject to the restrictive measures provided for in Council Decision (CFSP) 2023/2135, as amended by Council Decision (CFSP) 2025/2369 and Council Regulation (EU) 2023/2147, as implemented by Council Implementing Regulation (EU) 2025/2368 concerning restrictive measures in view of activities undermining the stability and political transition of Sudan

The following information is brought to the attention of the person that appear in the Annex to Council Decision (CFSP) 2023/2135 ⁽¹⁾, as amended by Council Decision (CFSP) 2025/2369 ⁽²⁾, and in Annex I to Council Regulation (EU) 2023/2147 ⁽³⁾, as implemented by Council Implementing Regulation (EU) 2025/2368 ⁽⁴⁾, concerning restrictive measures in view of activities undermining the stability and political transition of Sudan.

The Council of the European Union has decided that this person should be included in the list of persons and entities subject to restrictive measures provided for in Decision (CFSP) 2023/2135 and in Regulation (EU) 2023/2147 concerning restrictive measures in view of activities undermining the stability and political transition of Sudan. The grounds for the designation of this person appear in the relevant entry in those Annexes.

The attention of the person concerned is drawn to the possibility of making an application to the competent authorities of the relevant Member State(s) as indicated in the websites in Annex II to Regulation (EU) 2023/2147, in order to obtain an authorisation to use frozen funds for basic needs or specific payments (cf. Article 3 of the Regulation).

The person concerned may submit a request to the Council **before 29 May 2026**, together with supporting documentation that the decision to include them on the above-mentioned list should be reconsidered to the following address:
