

DECISION OF THE EEA JOINT COMMITTEE No 194/2017

of 27 October 2017

amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement [2019/1357]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area ('the EEA Agreement'), and in particular Article 98 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2017/1145 of 8 June 2017 on the withdrawal from the market of certain feed additives authorised pursuant to Council Directives 70/524/EEC and 82/471/EEC and repealing the obsolete provisions authorising those feed additives ⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Implementing Regulation (EU) 2017/1145 repeals Commission Regulations (EC) No 937/2001 ⁽²⁾, (EC) No 871/2003 ⁽³⁾, (EC) No 277/2004 ⁽⁴⁾, (EC) No 278/2004 ⁽⁵⁾, (EC) No 1332/2004 ⁽⁶⁾, (EC) No 1463/2004 ⁽⁷⁾, (EC) No 1465/2004 ⁽⁸⁾, (EC) No 833/2005 ⁽⁹⁾, (EC) No 492/2006 ⁽¹⁰⁾, (EC) No 1443/2006 ⁽¹¹⁾, (EC) No 1743/2006 ⁽¹²⁾, (EC) No 757/2007 ⁽¹³⁾ and (EC) No 828/2007 ⁽¹⁴⁾ which are incorporated into the EEA Agreement and which are consequently to be repealed under the EEA Agreement.
- (3) This Decision concerns legislation regarding feedingstuffs. Legislation regarding feedingstuffs shall not apply to Liechtenstein as long as the application of the Agreement between the European Community and the Swiss Confederation on trade in agricultural products is extended to Liechtenstein, as specified in the sectoral adaptations to Annex I to the EEA Agreement. This Decision is therefore not to apply to Liechtenstein.
- (4) Annex I to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Chapter II of Annex I to the EEA Agreement shall be amended as follows:

Article 2

The text of Implementing Regulation (EU) 2017/1145 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 28 October 2017, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).

Article 4

This Decision shall be published in the EEA Section of, and in the EEA Supplement to, the *Official Journal of the European Union*.
