POLITICAL AND SECURITY COMMITTEE DECISION (CFSP) 2025/2613

of 10 December 2025

on the appointment of the Head of Mission of the European Union Integrated Border Management Assistance Mission in Libya (EUBAM Libya) (EUBAM Libya/2/2025)

THE POLITICAL AND SECURITY COMMITTEE,

Having regard to the Treaty on European Union, and in particular Article 38, third paragraph, thereof,

Having regard to Council Decision 2013/233/CFSP of 22 May 2013 on the European Union Integrated Border Management Assistance Mission in Libya (EUBAM Libya) ⁽¹⁾, and in particular Article 9(1) thereof,

Whereas:

- (1) Pursuant to Article 9(1) of Decision 2013/233/CFSP, the Political and Security Committee (PSC) is authorised, in accordance with Article 38, third paragraph, of the Treaty, to take the relevant decisions for the purpose of exercising political control and strategic direction of the European Union Integrated Border Management Assistance Mission in Libya (EUBAM Libya), including the decision to appoint a Head of Mission, upon a proposal from the High Representative of the Union for Foreign Affairs and Security Policy (the 'High Representative').
- (2) On 8 December 2023, the PSC adopted Decision (CFSP) 2023/2784 ⁽²⁾, appointing Mr Jan VYČÍ TAL as Head of Mission of EUBAM Libya from 1 January 2024 to 30 June 2025.
- (3) On 25 June 2025, the PSC adopted Decision (CFSP) 2025/1326 ⁽³⁾, extending the mandate of Mr Jan VYČÍ TAL as Head of Mission of EUBAM Libya from 1 July 2025 to 31 December 2025.
- (4) On 24 November 2025, the High Representative proposed the appointment of Mr Frederik PETERSEN as Head of Mission of EUBAM Libya from 1 January 2026 to 31 December 2026.
- (5) A decision on the appointment of Mr Frederik PETERSEN as Head of Mission of EUBAM Libya from 1 January 2026 to 31 December 2026 should therefore be taken,

HAS ADOPTED THIS DECISION:

Article 1

Mr Frederik PETERSEN is hereby appointed as Head of Mission of the European Union Integrated Border Management Assistance Mission in Libya (EUBAM Libya) from 1 January 2026 to 31 December 2026.

Article 2

This Decision shall enter into force on the date of its adoption.
