



DECISION OF THE EEA JOINT COMMITTEE No 42/2026
of 6 February 2026
amending Annex XIII (Transport) to the EEA Agreement [2026/966]

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area (“the EEA Agreement”), and in particular Article 98 thereof,

Whereas:

- (1) Regulation (EU) 2024/1258 of the European Parliament and of the Council of 24 April 2024 amending Regulation (EC) No 561/2006 as regards minimum requirements on minimum breaks and daily and weekly rest periods in the occasional passenger transport sector and as regards Member States’ power to impose penalties for infringements of Regulation (EU) No 165/2014 committed in another Member State or in a third country⁽¹⁾ is to be incorporated into the EEA Agreement.
- (2) Commission Implementing Decision (EU) 2024/773 of 4 March 2024 amending Decision 2009/992/EU as regards minimum requirements for additional data to be entered in the national electronic register of road transport undertakings⁽²⁾ is to be incorporated into the EEA Agreement.
- (3) Annex XIII to the EEA Agreement should therefore be amended accordingly,

HAS ADOPTED THIS DECISION:

Article 1

Annex XIII to the EEA Agreement is amended as follows:

1. The following is added in point 19aa (Commission Decision 2009/992/EU):
‘as amended by:
 - **32024 D 0773**: Commission Implementing Decision (EU) 2024/773 of 4 March 2024 (OJ L, 2024/773, 6.3.2024).’
2. The following indent is added in point 24e (Regulation (EC) No 561/2006 of the European Parliament and of the Council):
‘— **32024 R 1258**: Regulation (EU) 2024/1258 of the European Parliament and of the Council of 24 April 2024 (OJ L, 2024/1258, 2.5.2024).’

Article 2

The texts of Regulation (EU) 2024/1258 and Implementing Decision (EU) 2024/773 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the *Official Journal of the European Union*, shall be authentic.

Article 3

This Decision shall enter into force on 7 February 2026, provided that all the notifications under Article 103(1) of the EEA Agreement have been made (*).
