## REGULATION No 14/66/EURATOM OF THE COUNCIL

of 24 November 1966

amending the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Federal Republic of Germany

THE COUNCIL OF THE EUROPEAN ATOMIC ENERGY COMMUNITY,

Having regard to Regulation No 31 (EEC), 11 (EAEC)<sup>1</sup> on the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Atomic Energy Community, and in particular the second paragraph of Article 4 and Article 94 and 95 of those Conditions of Employment;

Having regard to the proposal from the Commission;

Whereas, in view of the increases in remuneration granted to staff covered by the *Bundes-Ange-stellten-tarifvertrag*, Council Regulation No. 9/65/Euratom<sup>2</sup> laying down the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Federal Republic of Germany should be amended;

HAS ADOPTED THIS REGULATION:

*Article 1*

Regulation No 9/65/Euratom shall be amended as follows:

1. In Article 3 (a), 'DM 50' shall be substituted for 'DM 40'.

In Article 3 (b), 'DM 85' shall be substituted for 'DM 80'.

2. In Article 7 the following paragraph shall be added:

'Where a child is born to a member of establishment staff, that member shall receive an allowance of DM 165. If the mother and the father are both employed in institutions of the three European Communities, the allowance shall be paid only to the head of the family.'

3. The following paragraph shall be added to Article 9:

'Article 76 of the Staff Regulations shall apply by analogy to members of establishment staff, to former members of establishment staff or to beneficiaries of deceased members of establishment staff.'

4. The following shall be substituted for the Annex:
