

**REGULATION (EEC) No 1047/73 OF THE COMMISSION**  
**of 17 April 1973**

**amending Regulation (EEC) No 1080/68 on the procedure for calculating the levy on products processed from cereals and from rice and for the advance fixing of the levy for some of these products.**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation No 120/67/EEC<sup>(1)</sup> of 13 June 1967 on the common organization of the market in cereals as last amended by the Act<sup>(2)</sup> annexed to the Treaty<sup>(3)</sup> concerning the Accession of new Member States to the European Economic Community and the European Atomic Energy Community signed at Brussels on 22 January 1972, and in particular Article 15 thereof ;

Whereas Council Regulation (EEC) No 2429/72<sup>(4)</sup> of 21 November 1972 concerning the suspension of the application of the provisions for the advance fixing of levies and export refunds in different sectors of the common organization of the market lays down certain measures, including in particular an hour of the day by which applications for certificates must be lodged ;

Whereas Commission Regulation (EEC) No 1080/68<sup>(5)</sup> of 26 July 1968, as last amended by Regulation (EEC) No 2764/71<sup>(6)</sup> does not specify precisely the hour of the day on which applications for certificates must be lodged ; whereas it should therefore be supplemented ;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Cereals ;

HAS ADOPTED THIS REGULATION :

*Article 1*

The first and second subparagraphs of Article 3 (1) of Regulation (EEC) No 1080/68 are replaced by the following :

'1. The levy on imports of products falling within subheadings 07.06 A, 11.06 A, 11.07 and 23.02 A of the Common Customs Tariff applicable on the day on which the application for the certificate is lodged shall be applied, upon request being lodged by the applicant before 1 p. m. when applying for the certificate, to imports effected during the period of validity of the certificate.

In the case referred to in the foregoing paragraph, the levy shall where appropriate be adjusted by reference to the threshold price of the basic product or products used in the calculation of the variable component of the levy in force during the month of importation, without prejudice to the possible application of the second subparagraph of Article 15 (3) of Regulation No 120/67/EEC.'

*Article 2*

This Regulation shall enter into force on the day following its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
