

REGULATION (EEC) No 1969/73 OF THE COUNCIL
of 19 July 1973

laying down the provisions on the repealing of the suspension of the import charges and the compensatory amounts for beef and veal

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to the Treaty⁽¹⁾ concerning the Accession of new Member States to the European Economic Community and the European Atomic Energy Community, and in particular Article 62 (1) of the Act annexed thereto;

Having regard to Council Regulation (EEC) No 805/68⁽²⁾ of 27 June 1968 on the common organization of the market in beef and veal, as last amended by Regulation (EEC) No 187/73⁽³⁾, and in particular Article 17 (2) thereof;

Having regard to the proposal from the Commission;

Whereas the import charges and the compensatory amounts for beef and veal have been suspended until 16 September 1973 by Council Regulation (EEC) No 182/73⁽⁴⁾, as last amended by Regulation (EEC) No 1331/73⁽⁵⁾, in order to relieve the scarcity situation within the Community;

Whereas the market prices of adult bovine animals show a decreasing tendency; whereas for that reason it is possible that the maintenance of the suspension until 16 September is no longer justified; whereas in that respect provisions should be made immediately to terminate this suspension when the price situation in the Community no longer justifies its maintenance;

Whereas a time should be provided allowing for the realization of current operations;

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 19 July 1973.

HAS ADOPTED THIS REGULATION:

Article 1

The system provided for in Regulation (EEC) No 182/73 shall terminate when the Commission finds that the price for adult bovine animals on the representative markets of the Community, established in accordance with Article 10 of Regulation (EEC) No 805/68, is less than 103 % of the guide price during one week.

The first week where the price is taken into consideration shall be the week starting on the Monday preceding the entry into force of this Regulation.

Article 2

In the trade between the Member States and trade with third countries the provisions of Commission Regulation (EEC) No 1344/72⁽⁶⁾ of 28 June 1972 fixing the transit time to be applied when raising the customs duty or the levies, suspended in case of an appreciable increase in prices in the beef and veal sector, shall be applied. However, the end of such transit time shall, in no case, be later than 16 September 1973.

Article 3

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.
