

**REGULATION (EEC) No 2927/75 OF THE COMMISSION**  
**of 7 November 1975**  
**amending Regulation (EEC) No 232/75 on the sale of butter and reduced prices**  
**for use in the manufacture of pastry products and ice cream**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community ;

Having regard to Council Regulation (EEC) No 804/68 <sup>(1)</sup> of 27 June 1968 on the common organization of the market in milk and milk products, as last amended by Regulation (EEC) No 740/75 <sup>(2)</sup>, and in particular Article 6 (7) thereof ;

Having regard to Council Regulation (EEC) No 985/68 <sup>(3)</sup> of 15 July 1968 laying down general rules for intervention on the market in butter and cream, as last amended by Regulation (EEC) No 2714/72 <sup>(4)</sup>, and in particular Article 7a thereof ;

Whereas Commission Regulation (EEC) No 232/75 <sup>(5)</sup> of 30 January 1975 on the sale of butter at reduced prices for use in the manufacture of pastry products and ice cream, as last amended by Regulation (EEC) No 2586/75 <sup>(6)</sup>, provides that the butter put up for sale must have been taken into storage before 1 May 1975 ; whereas, having regard to the butter storage position in the Community, this date should be altered ;

Whereas, in order to avoid speculative purchases, the amount of the security for tendering should be varied ;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Milk and Milk Products,

HAS ADOPTED THIS REGULATION :

*Article 1*

Regulation (EEC) No 232/75 is amended as follows :

1. In Article 1, the date '1 May 1975' is replaced by '1 July 1975.'
2. In Article 8 (1), the amount '30 units of account' is replaced by '50 units of account'.

*Article 2*

This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
