

COMMISSION REGULATION (EEC) No 653/76

of 24 March 1976

amending the Annexes to Regulations (EEC) No 136/76, (EEC) No 336/76 and (EEC) No 638/76 fixing, pursuant to the invitation to tender opened by Regulations (EEC) No 3354/75, (EEC) No 135/76 and (EEC) No 357/76, the minimum selling price for skimmed-milk powder

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 974/71 of 12 May 1971 on certain measures of conjunctural policy to be taken in agriculture following the temporary widening of the margins of fluctuation for the currencies of certain Member States ⁽¹⁾, as last amended by Regulation (EEC) No 557/76 ⁽²⁾, and in particular Article 6 thereof,

Whereas Commission Regulation (EEC) No 136/76 of 22 January 1976 ⁽³⁾, as last amended by Regulation (EEC) No 573/76 ⁽⁴⁾, fixed the minimum selling price for skimmed-milk powder pursuant to the invitation to tender opened by Regulation (EEC) No 3354/75; whereas Commission Regulation (EEC) No 336/76 of 17 February 1976 ⁽⁵⁾, as last amended by Regulation (EEC) No 573/76, fixed the minimum selling price for skimmed-milk powder pursuant to the invitation to tender opened by Regulation (EEC) No 135/76; whereas Commission Regulation (EEC) No 638/76 of 23 March 1976 ⁽⁶⁾ fixed the minimum selling price for skimmed-milk powder pursuant to the invitation to tender opened by Regulation (EEC) No 357/76;

This Regulation shall be binding in its entirety and directly applicable in all Member States.

Done at Brussels, 24 March 1976.

Whereas with effect from 25 March 1976 the monetary compensatory amounts will be introduced in respect of trade with France; whereas the Annexes to Regulations (EEC) No 136/76, (EEC) No 336/76 and (EEC) No 638/76 should consequently each be amended;

Whereas the measures provided for in this Regulation are in accordance with the opinions of the Management Committees for Milk and Milk Products, and for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

There shall be added to the Annexes to Regulations (EEC) No 136/76, (EEC) No 336/76 and (EEC) No 638/76 the column headed 'France' as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 25 March 1976.
