

## COMMISSION REGULATION (EEC) No 1010/78

of 18 May 1978

altering the rates of the refunds applicable to certain milk products exported in the form of goods not covered by Annex II to the Treaty

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products<sup>(1)</sup>, as last amended by Regulation (EEC) No 2560/77<sup>(2)</sup>, and in particular Article 17 (5) thereof,

Whereas Commission Regulation (EEC) No 887/78 of 28 April 1978<sup>(3)</sup> has fixed the rates of the refunds applicable from 1 May 1978 to certain dairy products exported in the form of goods not covered by Annex II to the Treaty;

Whereas the rates of the refunds per 100 kilograms of each of the basic products concerned shall be fixed for each month, according to the first subparagraph of Article 4 (1) of Council Regulation (EEC) No 2682/72 of 12 December 1972 laying down general rules for granting export refunds on certain agricultural products exported in the form of goods not covered by Annex II to the Treaty, and criteria for fixing the amount of such refunds<sup>(4)</sup>, as last amended by Regula-

tion (EEC) No 707/78<sup>(5)</sup>; whereas this rule, established in order to create security conditions necessary for the processing industry to conclude their export contracts, should not form an obstacle to adjusting the rates of refunds during the month for which they were fixed in exceptional situations created by important fluctuations of the world market prices; it is therefore necessary to alter the rates of the refunds which applied to certain milk products exported in the form of products which are not included in Annex II to the Treaty,

HAS ADOPTED THIS REGULATION:

*Article 1*

The rates of the refunds applicable to certain milk products exported in the form of the products which appear in the Annex to Regulation (EEC) No 804/68 are hereby altered as shown in the Annex to this Regulation.

*Article 2*

This Regulation shall enter into force on 22 May 1978.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
