

COMMISSION REGULATION (EEC) No 584/78

of 22 March 1978

altering the components used to calculate the differential amounts for colza and rape seed

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats⁽¹⁾, as last amended by Regulation (EEC) No 2560/77⁽²⁾,

Having regard to Council Regulation (EEC) No 1569/72 of 20 July 1972 laying down special measures for colza and rape seed⁽³⁾, as last amended by Regulation (EEC) No 3477/73⁽⁴⁾, and in particular Article 3 thereof,

Whereas Commission Regulation (EEC) No 2300/73 of 23 August 1973⁽⁵⁾, as last amended by Regulation (EEC) No 1234/77⁽⁶⁾, laid down detailed rules of application for Regulation (EEC) No 1569/72; whereas the components used to calculate the differential amounts were fixed by Regulation (EEC) No 1423/77⁽⁷⁾, as last amended by Regulation (EEC) No 476/78⁽⁸⁾; whereas Commission Regulation (EEC) No 478/78 of 7 March 1978 on the calculation of monetary compensatory amounts and of differential amounts⁽⁹⁾ provided that for the fixing of the compensatory amounts and of the components used to calcu-

late the differential amounts during March 1978, the reference period to be taken into consideration should extend over a period of three weeks beginning on a Wednesday and ending on a Tuesday before the fixing; whereas, in the case of the pound sterling, the Irish pound and the French franc, the difference referred to in Article 2 (1) of Regulation (EEC) No 1569/72 for the period 1 to 21 March 1978 has changed, by reference to the representative rate valid on 27 March 1978, by at least one point from the percentage used for the previous fixing; whereas this fact should be taken into account when fixing the components used to calculate the differential amounts for colza and rape seed where those components are already applied in respect of the Member State concerned,

HAS ADOPTED THIS REGULATION :

Article 1

The Annex to amended Regulation (EEC) No 1423/77 is hereby replaced by the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 27 March 1978.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
