

**COMMISSION REGULATION (EEC) No 1877/87**  
**of 1 July 1987**  
**fixing the import levies on white sugar and raw sugar**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,  
Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 1785/81 of 30 June 1981 on the common organization of the markets in the sugar sector <sup>(1)</sup>, as last amended by Regulation (EEC) No 229/87 <sup>(2)</sup>, and in particular Article 16 (8) thereof,

Whereas, pending the fixing of the prices applicable for the 1987/88 marketing year, the threshold prices applicable on 30 June 1987 should be laid down pursuant to Commission Regulation (EEC) No 1826/87 of 29 June 1987 on precautionary measures and the suspension of advance fixing in certain agricultural sectors <sup>(3)</sup>;

Whereas the import levies on white sugar and raw sugar were fixed by Commission Regulation (EEC) No 2051/86 <sup>(4)</sup>, as last amended by Regulation (EEC) No 1860/87 <sup>(5)</sup>;

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 2051/86 to the information known to the Commission that the levies at present in force should be altered to the amounts set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

*Article 1*

The import levies referred to in Article 16 (1) of Regulation (EEC) No 1785/81 shall be, in respect of white sugar and standard quality raw sugar, as set out in the Annex hereto and will be adjusted, where appropriate, on the basis of the decisions taken in respect of prices for the 1987/88 marketing year.

*Article 2*

This Regulation shall enter into force on 2 July 1987.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
