

COMMISSION REGULATION (EEC) No 1996/91

of 8 July 1991

fixing the minimum selling prices for the purposes of the standing invitation to tender issued by Regulation (EEC) No 1995/91

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2727/75 of 29 October 1975 on the common organization of the market in cereals ⁽¹⁾, as last amended by Regulation (EEC) No 3577/90 ⁽²⁾, and in particular Article 7 (6) thereof,Having regard to Commission Regulation (EEC) No 1995/91 of 8 July 1991 on the sale for delivery in the French overseas departments of cereals held by the French, German and United Kingdom intervention agencies ⁽³⁾,Whereas Article 3 of Council Regulation (EEC) No 1581/86 of 23 May 1986 laying down general rules for intervention on the market in cereals ⁽⁴⁾, as last amended by Regulation (EEC) No 2003/90 ⁽⁵⁾, stipulates that when cereals held by intervention agencies are sold, they are to be sold by invitation to tender;Whereas Commission Regulation (EEC) No 1836/82 ⁽⁶⁾, as last amended by Regulation (EEC) No 2619/90 ⁽⁷⁾, lays down the procedures and the conditions for the disposal of cereals held by intervention agencies;

Whereas Regulation (EEC) No 1995/91 authorizes the French, German and United Kingdom intervention agen-

cies to put up for sale on the Community market 94 980 tonnes of cereals for delivery in the French overseas departments; whereas that Regulation provides for minimum selling prices to be fixed by way of a derogation from Article 5 (1) and (3) of Regulation (EEC) No 1836/82;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

The minimum selling prices to be observed for the purposes of the standing invitation to tender issued under Regulation (EEC) No 1995/91 shall be as set out in the Annex hereto.

*Article 2*This Regulation shall enter into force on the day of its publication in the *Official Journal of the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
