

COMMISSION REGULATION (EC) No 183/94**of 28 January 1994****determining the extent to which applications lodged in January 1994 for import
licences for certain poultrymeat products can be accepted**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 3834/90 of 20 December 1990 reducing for 1991 the levies on certain agricultural products originating in developing countries⁽¹⁾, as last amended by Regulation (EC) No 3668/93⁽²⁾,

Whereas the fixed amounts are those mentioned in the Annex to Regulation (EEC) No 3834/90; whereas Regulation (EC) No 3668/93 extends for the period 1 January to 30 June 1994 the application of Regulation (EEC) No 3834/90;

Whereas Commission Regulation (EC) No 3673/93⁽³⁾ set the quantity of poultrymeat that can be imported at a reduced levy for the period 1 January to 31 March 1994;Whereas Article 4 (5) of Commission Regulation (EEC) No 3809/91⁽⁴⁾, as amended by Regulation (EEC) No 581/92⁽⁵⁾, stipulates that the quantities applied for can be reduced; whereas applications for import licences for duckmeat lodged pursuant to that Regulation are for total quantities in excess of those available pursuant to Regula-

tion (EC) No 3673/93; whereas in order to ensure a fair allocation of those quantities those applied for should be reduced proportionately,

HAS ADOPTED THIS REGULATION:

Article 1

Applications for import licences for the period 1 January to 31 March 1994 submitted pursuant to Regulation (EC) No 3668/93 shall be granted:

- (a) for 21,0526 % of the quantity applied for, in the case of products covered by order No 59.0020 in Regulation (EEC) No 3834/90;
- (b) for 33,3333 % of the quantity applied for, in the case of products covered by order No 59.0025 in Regulation (EEC) No 3834/90.

Article 2

This Regulation shall enter into force on 29 January 1994.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
