*Article 1***List of recognised third countries**

*Article 3***Entry into force and application**

This Regulation shall enter into force on the third day following that of its publication in the *Official Journal of the European Union*.

It shall apply from 1 January 2022.

Article 1 shall apply until 31 December 2026.

Article 2 shall apply until 31 December 2024.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
