**COMMISSION IMPLEMENTING REGULATION (EU) 2024/1853**

**of 26 June 2024**

**entering a name in the register of protected designations of origin and protected geographical indications ('Lofotlam' (PGI))**

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1151/2012 of the European Parliament and of the Council of 21 November 2012 on quality schemes for agricultural products and foodstuffs <sup>(1)</sup>, and in particular Article 52(2) thereof,

Whereas:

- (1) Pursuant to Article 90(1) and (2) of Regulation (EU) 2024/1143 of the European Parliament and of the Council <sup>(2)</sup>, which repealed Regulation (EU) No 1151/2012, the latter Regulation remains applicable to applications for registration of geographical indications received by the Commission and published in the *Official Journal of the European Union* for opposition before 13 May 2024.
- (2) Pursuant to Article 50(2)(a) of Regulation (EU) No 1151/2012, Norway's application to register the name 'Lofotlam' as a protected geographical indication was published in the *Official Journal of the European Union* <sup>(3)</sup>.
- (3) As no reasoned statement of opposition under Article 51 of Regulation (EU) No 1151/2012 has been received by the Commission, the name 'Lofotlam' should therefore be entered in the register,

HAS ADOPTED THIS REGULATION:

*Article 1*

The name 'Lofotlam' (PGI) is hereby entered in the register.

*Article 2*

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
