COMMISSION IMPLEMENTING REGULATION (EU) 2024/1867

of 28 June 2024

entering a name in the register of protected designations of origin and protected geographical indications ('Miel de Ibiza/Mel d'Eivissa' (PDO))

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 1151/2012 of the European Parliament and of the Council of 21 November 2012 on quality schemes for agricultural products and foodstuffs ⁽¹⁾, and in particular Article 52(2) thereof,

Whereas:

- (1) Pursuant to Article 90(1) and (2) of Regulation (EU) 2024/1143 of the European Parliament and of the Council ⁽²⁾, which repealed Regulation (EU) No 1151/2012, the latter Regulation remains applicable to applications for registration of geographical indications received by the Commission and published in the *Official Journal of the European Union* for opposition before 13 May 2024.
- (2) Pursuant to Article 50(2)(a) of Regulation (EU) No 1151/2012, Spain's application to register the name 'Miel de Ibiza/Mel d'Eivissa' as a protected designation of origin was published in the *Official Journal of the European Union* ⁽³⁾.
- (3) As no statement of opposition under Article 51 of Regulation (EU) No 1151/2012 has been received by the Commission, the name 'Miel de Ibiza/Mel d'Eivissa' should therefore be entered in the register,

HAS ADOPTED THIS REGULATION:

Article 1

The name 'Miel de Ibiza/Mel d'Eivissa' (PDO) is hereby entered in the register.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the *Official Journal of the European Union*.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
