**COMMISSION IMPLEMENTING REGULATION (EU) 2025/1132**

**of 3 June 2025**

**amending Implementing Regulations (EU) 2020/761 and (EU) 2020/1988 as regards tariff rate quotas for products originating in Ukraine in 2025**

THE EUROPEAN COMMISSION,

Having regard to Regulation (EU) No 1308/2013 of the European Parliament and of the Council of 17 December 2013 establishing a common organisation of the markets in agricultural products and repealing Council Regulations (EEC) No 922/72, (EEC) No 234/79, (EC) No 1037/2001 and (EC) No 1234/2007 <sup>(1)</sup>, and in particular Article 187 thereof,

Whereas:

- (1) Commission Implementing Regulation (EU) 2020/761 <sup>(2)</sup> lays down the rules for managing import and export tariff rate quotas for agricultural products through a system of import and export licences.
- (2) Commission Implementing Regulation (EU) 2020/1988 <sup>(3)</sup> lays down rules on the administration of import tariff rate quotas based on the chronological order in which customs declarations are accepted ('first come, first served' principle).
- (3) Regulation (EU) 2024/1392 of the European Parliament and of the Council <sup>(4)</sup> lays down temporary trade liberalisation measures that supplement trade concessions for Ukrainian products. That Regulation suspends all tariff-rate quotas established under Annex I-A to the Association Agreement between the European Union and the European Atomic Energy Community and their Member States, of the one part, and Ukraine, of the other part <sup>(5)</sup> (the 'Association Agreement') until 5 June 2025. After this date, trade between the Union and Ukraine is to revert to the rules established under the Association Agreement.
- (4) Taking into account that the tariff rate quotas under the Association Agreement are established for a full calendar year and the temporary trade-liberalisation measures under Regulation (EU) 2024/1392 cease to apply on 5 June 2025, point 5 of Appendix C to Annex I-A to Chapter 1 of Title IV of the Association Agreement applies by default and the tariff rate quotas will be pro-rated on a proportional basis for the remainder of the calendar year. Pro rata quantities calculated on the basis of whole calendar months of suspended tariff-rate quotas to be re-introduced should be clarified for the year 2025.

- (5) To ensure that there is no disruption in the possibility to use the quotas, tariff rate quotas with order numbers 09.4306, 09.4307, 09.4308, 09.4270, 09.4600, 09.4601, 09.4602, 09.4271, 09.4272, 09.4275, 09.4276, 09.4273 and 09.4274 managed through licences in accordance with Implementing Regulation (EU) 2020/761, should be administered in chronological order, based on the date on which customs declarations for release for free circulation are accepted, in accordance with the rules for managing tariff-rate quotas laid down in Commission Implementing Regulation (EU) 2015/2447 <sup>(6)</sup> for the period from 6 June 2025 to 31 December 2025. Some rules for managing these tariff rate quotas, such as tariff quota sub-periods, should be maintained.
- (6) As regards tariff rate quotas in the sector of eggs introduced to Implementing Regulation (EU) 2020/1988 by this Regulation, conversion factors according to the rates of yield should be introduced.
- (7) Regulation (EU) 2024/1392 applies until 5 June 2025. To ensure the effective management and timely application of the measures laid down in this Regulation, it should enter into force on the day following that of its publication and apply from 6 June 2025.
- (8) Implementing Regulations (EU) 2020/761 and (EU) 2020/1988 should therefore be amended accordingly.
- (9) The measures provided for in this Regulation are in accordance with the opinion of the Committee for the Common Organisation of the Agricultural Markets,

HAS ADOPTED THIS REGULATION:

#### *Article 1*

#### **Amendments to Implementing Regulation (EU) 2020/761**

Annexes II, VIII, IX, X, XI and XII to Implementing Regulation (EU) 2020/761 are amended in accordance with Annex I to this Regulation.

#### *Article 2*

#### **Amendments to Implementing Regulation (EU) 2020/1988**

Implementing Regulation (EU) 2020/1988 is amended as follows:

- (1) Annex I is amended in accordance with Annex II to this Regulation;
- (2) the text set out in Annex III to this Regulation is added as Annex VI.
