Some demolition of old property will be involved but the site runs substantially across open ground. The river Idle, a small river with a normally shallow river-bed, crosses the site.*

b) The work has been designed in Imperial terms. It comprises additions, alterations, repairs and demolitions to the existing oil fuel installation at HM Naval Base, Portland which consists of oil fuel tanks and pumps, sullage, steam and condensate pipework, filtration and dispensing facilities, together with associated civil engineering and road works.
The work will include the construction of three 2 300 ton tanks, two 500 ton tanks, approximately five miles of welded steel piping of 8, 10, 12 and 16 inch diameters, the associated valves and fittings and the supply and installation of 15 pump sets for Class 'C' type fuels. Applicable specifications will comprise British Standard, American Petroleum Institute, and the Department of the Environment specifications.
