

**COMMISSION DECISION****of 11 March 1983****concerning the Italian Republic pursuant to Article 13 (2) of Regulation (EEC, Euratom, ECSC) No 2892/77 concerning own resources accruing from value added tax****(Only the Italian text is authentic)****(83/144/EEC, Euratom, ECSC)**

THE COMMISSION OF THE EUROPEAN  
COMMUNITIES,

Having regard to the Treaty establishing the European  
Atomic Energy Community,

Having regard to the Treaty establishing the European  
Coal and Steel Community,

Having regard to the Treaty establishing the European  
Economic Community,

Having regard to Council Decision 70/243/ECSC,  
EEC, Euratom of 21 April 1970 on the replacement of  
financial contributions from Member States by the  
Communities' own resources <sup>(1)</sup>,

Having regard to Council Regulation (EEC, Euratom,  
ECSC) No 2892/77 of 19 December 1977 implemen-  
ting in respect of own resources accruing from value  
added tax the Decision of 21 April 1970 on the  
replacement of financial contributions from Member  
States by the Communities' own resources <sup>(2)</sup>, and in  
particular the first subparagraph of Article 9 (3), the  
second subparagraph of Article 11 (1) and Article 13  
(2) thereof,

Whereas the Commission, pursuant to Article 13 (2) of  
Regulation (EEC, Euratom, ECSC) No 2892/77,  
adopted, for 1979, Decision 80/513/EEC, Euratom,  
ECSC <sup>(3)</sup>, for 1980, Decision 81/1017/Euratom, ECSC,  
EEC <sup>(4)</sup> and, for 1981, Decision 82/810/ECSC, EEC,  
Euratom <sup>(5)</sup>;

Whereas the Italian Republic has requested the exten-  
sion of the earlier Decisions;

Whereas, for the early years of implementation of  
Sixth Council Directive 77/388/EEC of 17 May 1977  
on the harmonization of the laws of the Member States  
relating to turnover taxes — Common system of value  
added tax: uniform basis of assessment <sup>(6)</sup>, authoriza-  
tions should be granted annually;

Whereas the Advisory Committee on Own Resources  
has approved the report recording the opinions of its  
members on this Decision,

HAS ADOPTED THIS DECISION:

*Article 1*

Decision 80/513/EEC, Euratom, ECSC is extended for  
1982.

*Article 2*

This Decision is addressed to the Italian Republic.
