Adoption of projects financed from the resources of the European Development Fund

Following the favourable opinion delivered by the European Development Fund Committee, through written procedure terminating on 8 July 1977 and at its 119th meeting held on 11 and 12 July 1977, the Commission took new financing decisions on 18, 22 and 27 July 1977 under the second, third and fourth EDFs, of which 31 involving grants and three involving loans on special terms.

1. Republic of the Ivory Coast

- -- Project No 4100.035.19.12
- Development of sheep-rearing in central Ivory Coast
- Amount: 1 868 000 EUA

The Government of Ivory Coast, pursuing its aim of modernizing sheep-rearing, has decided to launch this pilot scheme initially in the central region before gradually extending it to the rest of the country.

The main elements of the project are animal health schemes and the establishment of a National Sheep Centre to spread the techniques and know-how that will enable the original stock to be expanded and to introduce intensive supervised rearing schemes in villages in the area and then throughout the country as a whole.

EEC financing will cover the supply of pharmaceutical preparations, vaccines and minor veterinary equipment, the construction of buildings (accommodation, technical buildings), the supply of divers agricultural equipment and vehicles and the provision of technical assistance. The contracts for the construction and land clearance work will be awarded by local invitation to tender or restricted consultation procedure, while the supplies will be acquired by international invitation to tender.

2. United Republic of Tanzania

- Project No 4100.041.50.12
- Strengthening and asphalting the Nyanguge-Bunda road (120 km)
- Amount: 21 300 000 EUA

This project involves the strengthening and asphalting of a 120-km section of the Lake Victoria circuit road between Bukoba and Musoma.

As the project area is of increasing importance for industry and agriculture, the Tanzania Government gives this project priority in its road programme; it is, moreover, an important communication route between southern Uganda, Rwanda, Burundi and Kenya.

The works will be carried out in a single lot following an international invitation to tender issued to firms chosen by the preselection procedure

3. Democratic Republic of Madagascar

- Project No 4100.041.35.07
- Construction of three bridges over the Iaroka,
 Faraony and Namorona rivers
- Amount: 4 620 000 EUA

The aim of this project is to build three bridges, each approximately 150 m in length, over the rivers Iaroka, Faraony and Namorona, and to provide them with a total of 1 370 m of access roads. The scheme is designed to replace three existing ferries which are too old and too small to provide a regular service capable of coping with the steadily increasing traffic load. It should

also improve the transport facilities for marketing the agricultural produce of the region concerned.

An international invitation to tender will be issued for the works, which will be carried out in one or more lots.

4. Kingdom of Lesotho

- Project No 4100.041.33.06
- Improvement of the Quthing-Qachas Nek
- Amount: 1 000 000 EUA

This project involves the improvement of some 140 km of the worst stretches still to be re-made between Quthing and Qachas Nek (a total distance of 211 km).

The total cost of the project, which will be carried out by direct labour, is estimated at 1 300 000 EUA. The EEC is providing a grant of 1 000 000 EUA; the balance will be covered by the Lesotho budget.

5. The Caribbean (St Vincent)

- Project No 4100.041.71.01
- Reconstruction of the Georgetown-Peruvian Vale road (17 km)
- Amount: 1 920 000 EUA

This project involves the reconstruction and strengthening of the road connecting Peruvian Vale to Georgetown (17 km); this section is the northern part of the Windward Highway, linking the most important agricultural area of the island, located in the east, with the capital and deep-water harbour of St Vincent.

The total cost of the project is estimated at 1 920 000 EUA. This estimate takes into account the fact that the works will be carried out by direct labour and also includes the cost of replacing 10 minor bridges, the purchase of additional equipment for the Department of Public Works, which will carry out the works, and expatriate technical assistance.

6. The Caribbean (Dominica)

- Project No 4100.041.71.02
- Coastal roads (36 km)
- Amount: 1 960 000 EUA

The project involves the bituminizing of two sections of the ring road linking the island's economic centres; the first section connects Salisbury and Portsmouth on the west coast, and the second connects Hatton Garden with Castle Bruce on the east coast.

The total cost of the project is estimated at 1 960 000 EUA. It will be carried out on a direct labour basis by the Department of Public Works, which will be supplied with additional equipment and foreign technical assistance.

7. Gabonese Republic

- Project No 4200.041.22.06
- Study for the Port Gentil-M'bine road
- Amount: 1 900 000 EUA

In view of the importance of Port Gentil and in order to make the development of its hinterland easier, the Government of Gabon has decided to look closely at the possibility of linking that town with the rest of the country by a modern road which would join the north-south highway between Libreville and the Congo frontier at M'bine, near Lambaréné.

The EDF project involves carrying out a detailed examination of the economic aspects of the proposed new road link and drawing up the technical dossiers necessary for the execution of the work.

The project will be carried out by a consultancy firm chosen by invitation to tender.

8. French Department of Rèunion

- Projects No 3111.038.05 and No 3300.043.38.04
- Port of Pointe des Galets development of open storage areas
- -- Amount: 468 800 EUA

This sum is intended to cover the cost of developing 28 400 m² of open storage area in the Port of Pointe des Galets, equipped with the various necessary services and connected with the existing access roads to the port.

The main works operations to be carried out are the following:

- 176 000 m³ of earthworks,
- a rainwater discharge system: a secondary network comprising a 300 mm pipe system linked to an existing main drainage pipe 1 000 mm in diameter,
- the provision of a drinking water system is confined to connecting up with the mains system (diameter 100 mm),
- surfacing,
- street lighting fencing.

The execution of the project will be the subject of an international invitation to tender by accelerated procedure.

9. French Guyana

- Project No 3400.043.34.03
- Port of Le Larivot construction of a fishing wharf
- Amount: 453 000 EUA

The aim of this project is the construction of a fishing wharf 76.40 m long between the two existing wharves at Le Larivot, 15 km from Cayenne, thereby forming a single wharf 446.40 m long.

The project involves the following:

- preliminary work,
- foundation on piles,
- execution of the superstructure,
- equipment.

An international invitation to tender (accelerated procedure) will be issued for the works.

10. Democratic Republic of the Sudan

- Project No 4100.051.48.12
- University of Juba
- Amount: 2 000 000 EUA

This project is aimed at backing up the efforts of the national authorities to install facilities for the first intake of students to the University of Juba, on the basis of an action plan drawn up by the university authorities in December 1976.

The project involves a housing scheme for staff and additional space for educational purposes and vocational training. Furthermore, all existing buildings which have been renovated will be adequately equipped and infrastructure work will be included to improve water and electricity supply.

The total cost of the project is estimated at approximately 3 650 000 EUA. The EEC is contributing 2 000 000 EUA and the remainder is being provided by the Democratic Republic of the Sudan itself.

The works will be carried out following an invitation to tender (accelerated procedure), and an international invitation to tender will be

issued for the supply of the equipment, furniture and fittings, to be divided into several lots according to the nature of the supplies.

11. Republic of Zaire

- Project No 4100.051.55.08
- Higher Institute of Applied Technology (ISTA)
- Amount: 6 600 000 EUA

As an integral part of the Zairian National University since 1971, the Higher Institute of Applied Technology (ISTA) aims at training highly-qualified technicians in mechanical and electrical engineering, electronics, meteorology and aeronautics. The studies last three years following secondary education.

The project financed by the EEC aims at providing the establishment with the additional premises which are essential to accommodate increased numbers of students, plus appropriate equipment (furniture, scientific apparatus and installations, machines, tools and workshop fittings and all the teaching material needed for the institute to function properly).

The construction work will be performed by contract, in a single lot, following an open international invitation to tender. The supply of the furniture and the teaching materials will also be the subject of an international invitation to tender, broken down into several lots according to the nature of the supplies.

12. Republic of Guinea

- Project No 4100.051.26.06
- Equipment for five secondary polytechnics (IPSs)
- Amount: 1 530 000 EUA

In its efforts to set up an educational system geared specifically to vocational training to meet the country's needs for a skilled workforce while making the best use of the existing training structures, the Guinean Government has set up a number of secondary polytechnics (IPSs).

The purpose of this project is to supply basic tools and materials for certain workshops in five IPSs (Conakry II '2 August', Kindia, Labé, Kankan 'Ho-Chi-Minh', N'Zérékoré) and to send out a teacher/technician for three months to put the equipment into service.

An international invitation to tender will be issued for the supply of the equipment and the

dossier for this will be drawn up by the Guinean education authorities.

13. Republic of Guinea

- Project No 4100.061.26.07
- Equipment for health units
- -- Amount: 2 000 000 EUA

This EEC-financed project is part of a scheme to improve diagnosis and treatment for patients and hence to fulfil the population's priority needs in the public health field.

It involves supplying the country's health units and hospitals with medical equipment and instruments and transport (ambulances, light vehicles for use by medical staff working in rural areas). At the same time, a scheme will be launched for the training of maintenance staff; it will involve making available the services of a technician/instructor for two years and the provision of training grants.

International invitations to tender will be issued for the supply of the equipment and vehicles. The invitation to tender dossiers will be drawn up by the departments of the Guinean Health Ministry and will be divided into lots according to the kind of services required. The purchases of replacement parts, spares and tools will be made on the basis of estimates.

14. Republic of Guinea

- -- Project No 4100.030.26.08
- Equipment of rural development brigades
- -- Amount: 14 273 000 EUA

This EEC-financed project falls within the framework of Guinea's 1973 to 1978 Multi-annual Development Plan, which is geared to rural development, and its aims are to increase agricultural production while making it more independent of climatic vagaries by the better control of water, and to improve living conditions for the rural population by more rational use of underground and surface water resources. The project is located in the regions of Haute Guinée (Kankan) and Moyenne Guinée (Labé).

The schemes to be implemented involve rural construction work (sheds, workshop, accommodation), the supply of rural engineering equipment (tractors, hydraulic and mechanical shovels, soil compactors, graders) and the purchase of miscellaneous equipment and vehicles. Technical assistance staff will also be provided for the purpose of the project. Lastly, specialized consultancy firms will be providing certain services (geophysical surveys, drawing up works schedules for hydro-agricultural development projects).

Since Guinea is itself covering all the costs for its own staff working on the project, the EEC's contribution amounts to 14 273 000 EUA; international invitations to tender will be issued for the capital expenditure.

15. Ethiopia

- Project No 4100.032.20.07
- Amibara irrigation project
- Amount: 14 996 000 EUA

By diverting the Awash River this project will provide gravity irrigation for about 10 300 ha. 7 500 ha of new land will be developed, mainly for cotton growing, comprising four state farms (6 700 ha) and an 800 ha settlement area for 320 Afar families.

Besides the actual work to divert the river water (weir, irrigation and drainage network, roads, on-farm development works), the project covers:

- the construction of project headquarters, workshop, stores, staff housing and related facilities for all stages of the development,
- the purchase of operation and maintenance equipment, vehicles and farm machinery,
- the provision of watering points to open up new grazing lands,
- the provision of technical assistance for project management and other forms of assistance for the state farms and the regional settlement programme.

The total cost of the project is put at 50 375 000 EUA, of which 30 % (14 996 000 EUA) will be financed by the EDF. The Ethiopian Government will itself provide 8 329 000 EUA. The other contributors will be the IDA and the African Development Fund.

International invitations to tender will be issued for the on-farm development and the supply of agricultural machinery and vehicles, but the construction of the buildings and housing will be the subject of accelerated public tendering procedures.

16. Central African Empire

- Project No 4100.031.17.07
- Improvement of coffee-growing on family plantations
- Amount: 4 600 000 EUA

The present project aims at increasing the productivity of the family-based coffee plantations spread over the whole of the coffee belt which stretches from the South-East to the South-West of the Central African Empire. The training and extension programme planned for a period of four years is intended to familiarize the people with improved methods of cultivation.

Community aid is to be used for:

- reinforcement of the plant propagation network and participation in credit operations for planters,
- technical assistance for the training and extension services, as well as participation in the supervision costs,
- technical assistance in the sphere of plant protection and support for the cooperatives.

The technical cooperation schemes will give rise to a mutual agreement procedure; the Commission of the European Communities will draw up the restricted list of consultancy firms possessing the required qualifications and it will be up to the Government of the Central African Empire to select from among these candidates the firm (or firms) with whom the contract will be signed.

17. All the ACP States

- Project No 4107.002.94.13
- Financing of experts and consultants for the General Secretariat of the ACP States
- Amount: 1 500 000 EUA

The project, which meets a request made by the Council of Ministers of the ACP States at the meeting of ACP-EEC Ministers held in Fiji in April 1977, is to enable the General Secretariat of the ACP States to cope with the increasing volume and complexity of the tasks it has to accomplish.

It consists of placing at the disposal of the General Secretariat a package of 1.5 million EUA to ensure that experts can be recruited, particularly at high level.

18. Trinidad and Tobago

- Project No 4200.043.54.06
- -- St Patrick fisheries
- Amount: 570 000 EUA

The project is part of a comprehensive programme to improve the working conditions and the standard of living of local inshore fishermen in the region of St Patrick.

The total cost will be 942 000 EUA. The contribution requested from the EDF is 570 000 EUA. This contribution will finance the supply and construction at each of five coastal localities (Icacos, Cedros, Fullerton, Otaheite and Morne Diable) of the following:

- a system for launching and beaching boats,
- a repair shed,
- individual lockers,
- -- cold storage facilities,
- and also the construction at two places, Cedros and Fullerton, of a jetty to allow boats to come alongside and unload their catches.

In addition the project provides for the purchase of fishing equipment, particularly boats, for an amount of 372 000 EUA, to be financed by the government and handled by the Agricultural Development Bank of Trinidad and Tobago.

The works will be carried out following an accelerated invitation to tender. International invitations to tender will be issued for the supplies (winches and equipment for cold storage).

19. Republic of Chad

- Project No 4100.061.51.07
- Campaign against major endemic diseases
- Amount: 100 000 EUA

The purpose of this project is to provide the Major Endemic Diseases Department (Service des Grandes Endémies (SGE)) with the medicinal preparations which are essential for its campaign against the various venereal diseases that are endemic in the country, particularly in rural areas. The supply of specific antibiotics will enable the SGE to carry out a three- or four-year scheme to halt the increase in venereal diseases in Chad.

An international invitation to tender will be issued for the supply of the medicinal preparations.

20. Republic of Sierra Leone

- Project No 4103.038.46.07
- First annual microproject programme
- Amount 300 000 EUA

In order to help it improve the economic and social situation of a number of rural communities in various districts, the Government of Sierra Leone has obtained the EEC's participation in microprojects involving the following:

- country roads and bridges,
- -- village water supplies,
- improvement of the treatment or storage of agricultural produce,
- construction of a jetty to facilitate marketing,
- construction of school buildings in rural areas,
- health centres,
- maternal and child health programme.

The EDF's contribution, totalling 300 000 EUA, represents on average 50 % of the cost of each project on the programme. The government contributions, mainly in kind, are estimated to be worth some 24 % of the total expenditure. The local communities, are also making contributions in kind (labour, materials and so on); for most of the microprojects these contributions are substantial, amounting in some cases to as much as 30 % of the cost of the project.

21. Republic of Upper Volta

- Project No 4103.038.30.13
- First annual mircroproject programme
- Amount: 186 000 EUA

The rural development schemes to be carried out in the villages under Upper Volta's first annual microproject programme involve the following:

- rural water engineering (wells, waterpoints, small dams),
- rural tracks (bridges and improvements to tracks),
- social infrastructure in rural areas (protection of mother and infant, social centres),
- improvement of production (fish farming, village re-afforestation).

These schemes will be executed and administered through the Rural Development Fund (FDR).

The EEC's contribution of 186 000 EUA represents 43 % of the overall cost of the microprojects. The State will contribute 36 % of the cost by supplying materials, supervisory staff and transport. The local communities, with an estimated contribution of 21 %, will provide mainly labour and local materials.

22. Republic of Djibouti

- Project No 4100.072.63.03
- Rural water supply (provision of drilling equipment)
- Amount: 650 000 EUA

The purpose of this project is to supply the Republic of Dijbouti with drilling equipment and the necessary means of transport to enable it to carry out deep drilling operations as part of a short-term rural water supply programme.

This equipment will make it possible to bring about a substantial improvement in the living conditions of the nomadic population by establishing water supply points and areas for fodder and food crop cultivation in places where the only permanent source of water is deep groundwater; in the longer term, the equipment will also make it possible to undertake further surveys with a view to the improved evaluation of groundwater resources and their exploitation for agricultural and industrial purposes.

The financing should cover the following costs:

- equipment for the drilling unit,
- extraction equipment for the boreholes and for maintenance of the installations,
- light equipment for groundwater table prospecting.

The drilling unit equipment will be the subject of an international invitation to tender. Restricted invitations to tender will be issued in respect of the extraction any prospecting equipment.

23. Republic of Djibouti

- Project No 4100.073.63.04
- Extensions to the Djibouti town drainage system
- Amount: 310 000 EUA

This project is necessary for the functioning of the Salines Area project, which was carried out under the third EDF at a cost of 3 071 000 EUA. The bulk of the aid will be spent on:

- (a) supplementary works (primary and secondary waste water networks); and
- (b) equipment needed to maintain the existing Djibouti drainage system.

Work on the primary structure will be carried out by local firms, on the basis of restricted invitations to tender.

Work on the secondary network will be carried out either under contract following a restricted invitation to tender where the terrain is difficult, or by public works departments in all other cases.

Restricted invitations to tender will be issued for the supply of equipment, attention being paid to the after-sales service conditions.

23. Republic of Djibouti

- Project No 4106.053.63.05
- Fixing of an interim training programme
- -- Amount: 70 000 EUA

This sum is to cover the cost of:

- a number of development planning scholarships, and
- the organization of a two- to three-month seminar to improve the qualifications of some 30 future middle- and higher-management staff.

24. Somali Democratic Republic

- Project No 4106.052.47.09
- Integrated training scheme for the Mogadishu General Hospital
- Amount: 800 000 EUA

This project is to finance a scheme to be run at the Mogadishu General Hospital involving:

- assistance with the setting-up of the hospital's technical department and with the coordination of a training scheme for management and maintenance staff,
- the provision of two instructors to run the training scheme for a three-year period,
- the construction of premises to house the technical department and its equipment.

For this new project, the central coordination scheme and the provision of instructors will involve the signing of technical assistance contracts. The construction work and supply of equipment will be carried out on the basis of estimates.

25. Republic of Ghana

- -- Project No 4104.091.24.12
- Exceptional aid
- Amount: 2 130 000 EUA

The past three years in Ghana have been marked by irregular and poor rainfall. Both cultivated acreage and yields have declined significantly. As a consequence food shortages have occurred, particularly in the northern and upland regions.

The Ghanaian authorities have launched a number of short- and long-term schemes to remedy this situation, especially as regards transport for food aid supplied by international sources.

It is in this context that the exceptional aid, which is the subject of the Financing Agreement, is to be given. It involves placing at the disposal of the Ghanaian Government the sum of 2 130 000 EUA for the purchase of vehicles, fuel and spare parts and for obtaining the necessary technical assistance to ensure that these vehicles are properly maintained.

26. Republic of Zambia

- Project No 4104.091.56.06
- Exceptional aid
- Amount: 8 000 000 EUA

The tense situation which has existed in southern Africa for several years has had increasingly harmful repercussions on Zambia's economy. In addition, the country has been having to cope for some time with a growing influx of refugees from Rhodesia, Angola und Namibia.

These general difficulties and the additional refugee burden, on top of which there is the new problem of unemployment among young people, have led the EEC to grant exceptional aid to Zambia for the purchase of agricultural machinery and equipment, transport and fertilizers.

27. Kingdom of Tonga

- Project No 4104.091.53.05
- -- Exceptional aid
- Amount: 200 000 EUA

This is to help cover the cost of repairing the damage caused by the earthquake of 26 June

1977 in the Tongatapu and Tuwa Islands. It should cover the bulk of the costs of the reconstruction teams and the purchase of equipment and building materials for repairs to schools and hospitals.

28. All ACP States

- Project No 4110.010.94.12
- EDF contribution to the 1977 annual budget of the Centre for Industrial Development
- Amount: 1 300 000 EUA

This aid will enable the Centre for Industrial Development to finance the following:

- promotional contacts and meetings,
- information and press relations,
- pre-feasibility studies,
- short-term expertise,
- assistance to existing industries and a training programme.

29. All ACP States and OCTD

- Project No 4106.001.94.17
- Fixing of an overall sum for the programme of basic and advanced training courses for the period 1 February 1977 to 31 December 1978
- Amount: 650 000 EUA

The aim of this project is to finance:

- (a) short training courses for ACP students or ACP nationals, particularly executives of national enterprises;
- (b) advanced training courses for ACP officials.

The programmes scheduled cover the period 1 February 1977 to 31 December 1978.

30. The Gabonese Republic

- -- Project No 4106.053.22.01
- Fixing of a multi-annual training programme
- Amount: 410 000 EUA

This training programme for the period 1976 to 1980 involves two schemes:

- (a) the granting of 25 scholarships in the sectors of agriculture, public works, transport and mechanical engineering;
- (b) the organization of training seminars, particularly in the fields of wood and management.

31. Republic of the Gambia

- Project No 4106.053.23.01
- Fixing of a multi-annual training programme
- Amount: 404 000 EUA

This training programme for the period 1976 to 1980 involves two schemes:

- (a) the granting of 77 scholarships in the fields of education, transport, agriculture and public works;
- (b) the organization of seminars and training sessions.

32. United Republic of Cameroon

- Project No 4106.053.16.01
- Multi-annual training programme, 1976 to 1980
- Amount: 2 230 000 EUA

The training programme covers the following schemes:

- (a) multi-annual scholarship programme:
 - 200 scholarships will be awarded, mainly in the sectors of project study and development and agricultural science;
- (b) provision of experts:
 - three teachers will be sent out for two years to the Institute of Statistics, Planning and Applied Economics in Yaoundé,
 - the financing of the hospital staff training scheme started under the third EDF will be continued.

For this scheme it will be necessary to provide the services of an expert for two years and to finance the purchase of the necessary pedagogical equipment.

33. Republic of Mali

- Project No 4106.053.37.01
- Fixing of an amount for the financing of a multi-annual training programme for 1976 to 1980

-- Amount: 1 500 000 EUA

The training programme involves the following schemes:
