Whe	reas:
(1)	In accordance with Article 28(2) and (3) and Article 34 of Commission Delegated Regulation (EU) 2019/33 (2), the Commission has examined the application for the approval of a modification to the traditional term 'Palo Cortado' forwarded by Spain and has published it in the Official Journal of the European Union (3).
(2)	No statement of objection has been received by the Commission under Article 22 of Commission Implementing Regulation (EU) $2019/34$ (4).
(3)	In accordance with Article 31(3) of Delegated Regulation (EU) 2019/33, the modification of the traditional term 'Palo Cortado' should therefore be approved and entered in the electronic register of protected traditional terms referred to in Article 25 of Implementing Regulation (EU) 2019/34.

HAS ADOPTED THIS REGULATION:

Article 1

The modification of the traditional term 'Palo Cortado' published in the Official Journal of the European Union is hereby approved.

Article 2

This Regulation shall enter into force on the twentieth day following that of its publication in the Official Journal of the European Union.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
