

DECISION OF THE EEA JOINT COMMITTEE**No 80/2002****of 25 June 2002****amending Annex I (Veterinary and phytosanitary matters) to the EEA Agreement**

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex I to the Agreement was amended by Decision of the EEA Joint Committee No 69/98 of 17 July 1998 ⁽¹⁾.
- (2) 16 acts regarding seeds are to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

Chapter III of Annex I to the Agreement shall be amended as specified in the Annex to this Decision.

Article 2
