DECISION OF THE EEA JOINT COMMITTEE

No 158/2004

of 29 October 2004

amending Annex XIII (Transport) to the EEA Agreement

THE EEA JOINT COMMITTEE,

Having regard to the Agreement on the European Economic Area, as amended by the Protocol adjusting the Agreement on the European Economic Area, hereinafter referred to as 'the Agreement', and in particular Article 98 thereof,

Whereas:

- (1) Annex XIII to the Agreement was amended by Decision of the EEA Joint Committee No 129/2004 of 24 September 2004 (¹).
- (2) Regulation (EC) No 2320/2002 of the European Parliament and of the Council of 16 December 2002 establishing common rules in the field of civil aviation security (²) was incorporated into the Agreement by Decision of the EEA Joint Committee No 61/2004 of 26 April 2004 (³), with country specific adaptations.
- (3) Commission Regulation (EC) No 1138/2004 of 21 June 2004 establishing a common definition of critical parts of security restricted areas at airports (⁴) is to be incorporated into the Agreement,

HAS DECIDED AS FOLLOWS:

Article 1

The following point shall be inserted after point 66l (Regulation (EC) No 785/2004 of the European Parliament and of the Council) of Annex XIII to the Agreement:

'66m. **32004 R 1138**: Commission Regulation (EC) No 1138/2004 of 21 June 2004 establishing a common definition of critical parts of security restricted areas at airports (OJ L 221, 22.6.2004, p. 6).'

Article 2

The texts of Regulation (EC) No 1138/2004 in the Icelandic and Norwegian languages, to be published in the EEA Supplement to the Official Journal of the European Union, shall be authentic.
