

**EUROPEAN AGRICULTURAL GUIDANCE AND GUARANTEE FUND**

**Granting of aid from EAGGF, Guidance Section, for 1964**

(65/449/EEC)

In accordance with Article 5 (2) of Regulation No 25 on the financing of the common agricultural policy and Articles 2 and 4 of the Financial Regulation concerning the EAGGF, an amount of 9 057 000 units of account is entered in the Community budget for the 1965 financial year under Chapter LXXX entitled 'Action undertaken within the framework of the Guidance Section, first 1964 instalment'. This instalment represents one-third of the amount fixed for corresponding expenditure from the Guarantee Section, i.e. expenditure for the 1962/63 accounting period.

By 1 July 1964, 226 applications had been submitted to the Commission through the Member States concerned, in accordance with Article 20 of Regulation No 17/64/EEC. 19 of those applications were subsequently withdrawn by the applicants.

Of the 207 applications finally submitted, 69 were considered not to fulfil the conditions necessary for projects to receive aid from the Fund, since it was found that they did not comply with the express provisions of Regulation No 17/64/EEC for one or other of the following reasons:

- the approval of the Member State concerned was not given in accordance with Article 20 (3) of that Regulation;

- the projects were already being carried out on the day on which the application was lodged with the Commission.

This finding has been communicated to the respective applicants and to the Member States concerned.

The 138 remaining projects represented a total of 21 418 540 units of account in application for aid.

The Commission, consulted the Fund Committee on the financial aspects and in particular on the finances available, and after having obtained the Opinion to the Standing Committee on Agricultural Structure accepted the 57 projects, representing a total 9 056 922 units of account, shown on the attached list. These were the projects which seemed to it to be most in accordance with the Community's interest, bearing in mind:

- the priority laid down in Article 15 of Regulation No 17/64/EEC;
- the need to share out aid from the Fund harmoniously within the Community.

In accordance with Article 21 of Regulation No 17/64/EEC, the Commission Decisions granting Fund aid for the projects indicated below have been communicated to the Member States concerned and to the beneficiaries.
