## REGULATION (EURATOM) No 2000/69 OF THE COUNCIL

of 6 October 1969

amending the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Netherlands

THE COUNCIL OF THE EUROPEAN COMMUNITIES,

Having regard to Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup> of 29 February 1968 on the Staff Regulations of Officials of the European Communities and the Conditions of Employment of Other Servants of the Communities, and in particular the second paragraph of Article 4 and Articles 94 and 95 of those Conditions of Employment;

Having regard to Council Regulation No 11/65/Euratom<sup>2</sup> of 16 March 1965 laying down the conditions governing remuneration and social security for establishment staff of the Joint Nuclear Research Centre employed in the Netherlands, as last amended by Regulation (Euratom) No 759/68,<sup>3</sup> and in particular Article 13 thereof;

Having regard to the proposal from the Commission;

Whereas it is for the Council, acting on a proposal from the Commission, to lay down, in the light of local practice, the conditions governing remuneration for establishment staff of the Joint Nuclear Research Centre at each place of employment;

Whereas in view of the changes in salaries for the year 1968 for the staff of the *Reactor Centrum Nederland*, Article 3 of Regulation No 11/65/Euratom should be amended;

Whereas in view of the changes in salaries made since 1 January 1969 for the staff of the *Reactor Centrum Nederland*, Regulation No 11/65/Euratom should be further amended;

HAS ADOPTED THIS REGULATION:

*Article 1*

The following provisions shall be added to Article 3 of Regulation No 11/65/Euratom:

'A single allowance equal to fl 116 shall be granted for the year 1968. This allowance shall be paid to staff who have been employed as members of establishment staff during the whole of the year 1968. Staff who have been employed for less than twelve months shall receive an allowance calculated in proportion to the number of completed months of service, any period of fifteen days or more being counted as a completed month.'

*Article 2*

The following scale shall be substituted for the scale of salaries shown in the Annex to Regulation No 11/65/Euratom:
