

REGULATION (EEC) No 1786/71 OF THE COMMISSION

of 13 August 1971

amending Regulation (EEC) No 1738/71 on the non-application of the system of import licences for imports of tomato concentrates from third countries

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 865/68¹ of 28 June 1968 on the common organisation of the market in products processed from fruit and vegetables, as last amended by Regulation (EEC) No 1425/71²;

Having regard to Council Regulation (EEC) No 1427/71³ of 2 July 1971 introducing protective measures for products processed from fruit and vegetables, and in particular Article 1 (2) thereof;

Whereas certain third countries have declared themselves willing and in a position to guarantee that on importation into the Community of tomato concentrates from their territory the price will not be below a certain minimum level and that all deflection of trade will be prevented; whereas because of this Commission Regulation (EEC) No 1738/71⁴ of 6 August 1971 provided for the non-application to imports from third countries of the system of import licences referred to in Article 1 (1) of Commission Regulation (EEC) No 1558/71⁵ of 20 July 1971 laying down protective measures applicable to imports of tomato concentrates.

Whereas the Government of the Republic of Tunisia has since declared that it is willing to give this guarantee for exports of tomato concentrates to the Community from 16 August 1971 and to take the necessary measures to this effect; whereas the

Government of the Swiss Confederation has declared that it is willing to give this guarantee from the same date for exports of tomato concentrates with a dry matter content of not less than 95% and to take the necessary measures to this effect; whereas, therefore, the provisions of Article 1 (4) of Regulation (EEC) No 1558/71 should be extended to include imports from these third countries;

HAS ADOPTED THIS REGULATION:

Article 1

The following list shall be substituted for the list in Article 1 of Regulation (EEC) No 1738/71 of 6 August 1971:

1. Spain.
2. Portugal.
3. Morocco.
4. Tunisia.
5. Switzerland.

(with regard to tomato concentrates with a dry matter content of at least 95%).

Article 2

This Regulation shall enter into force on 16 August 1971.
