

REGULATION (EEC) No 2866/73 OF THE COMMISSION
of 19 October 1973
concerning notification to the Commission by the Member States of import
licences issued for wine

THE COMMISSION OF THE EUROPEAN
COMMUNITIES,

Having regard to the Treaty establishing the European
Economic Community ;

Having regard to Council Regulation (EEC) No
816/70⁽¹⁾ of 28 April 1970 laying down additional
provisions for the common organization of the market
in wine, as last amended by Regulation (EEC) No
2680/72⁽²⁾, and in particular Article 35 thereof ;

Whereas pursuant to Article 10 of Regulation (EEC)
No 1014/70⁽³⁾ on import licences for wine, as last
amended by Regulation (EEC) No 1373/70⁽⁴⁾,
Member States must notify the Commission every
week of the import licences issued ;

Whereas experience has shown that such notice
should be given every fifteen days and be presented in
a standard form ;

Whereas the measures provided for in this Regulation
are in accordance with the Opinion of the Manage-
ment Committee for Wine,

HAS ADOPTED THIS REGULATION :

Article 1

Member States shall on the days specified below
notify the Commission of the quantities of products
for which import licences have been issued during the
periods shown :

on the 5th day of each month for the period from the
16th to the last day of the preceding month,
on the 20th day of each month for the period from
the 1st to the 15th day of the current month,
in accordance with Annex.

Article 2

Regulation (EEC) No 1014/70 is repealed.

Article 3

This Regulation shall enter into force on the third day
following its publication in the *Official Journal of
the European Communities*.

This Regulation shall be binding in its entirety and directly applicable in all Member
States.
