REGULATION (EEC) No 1240/74 OF THE COMMISSION of 16 May 1974

altering components used to calculate the differential amounts for colza and rape seed

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 136/ 66/EEC (1) of 22 September 1966 on the establishment of a common organization of the market in oils and fats as last amended by Regulation (EEC) No $1707/73(^{2});$

Having regard to Council Regulation (EEC) No 1569/72 (3) of 20 July 1972 laying down special measures for colza and rape seed, as last amended by Regulation (EEC) No 3477/73 (4), and in particular Article 3 thereof;

Whereas Commission Regulation (EEC) 2300/73 (5) of 23 August 1973, as last amended by Regulation (EEC) No 456/74 (6), laid down detailed rules of application for Regulation (EEC) No 1569/72; whereas the components used to calculate the differential amounts are fixed by Regulation (EEC) No 451/74 (7), as last amended by Regulation (EEC) No 1168/74 (8); whereas the difference in accordance with Article 2 (1) of Regulation (EEC) No 1569/72 for the pound sterling for the period 8 to 14 May 1974 departs by at least 1 point from the percentage used for the previous fixing; whereas this fact should be taken into account when the components used to calculate the differential amounts for colza and rape seed are fixed,

HAS ADOPTED THIS REGULATION:

Article 1

The Annex to amended Regulation (EEC) No 451/74 is replaced by the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 20 May 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
