

REGULATION (EEC) No 1240/74 OF THE COMMISSION**of 16 May 1974****altering components used to calculate the differential amounts for colza and rape seed**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 136/66/EEC⁽¹⁾ of 22 September 1966 on the establishment of a common organization of the market in oils and fats as last amended by Regulation (EEC) No 1707/73⁽²⁾;

Having regard to Council Regulation (EEC) No 1569/72⁽³⁾ of 20 July 1972 laying down special measures for colza and rape seed, as last amended by Regulation (EEC) No 3477/73⁽⁴⁾, and in particular Article 3 thereof;

Whereas Commission Regulation (EEC) No 2300/73⁽⁵⁾ of 23 August 1973, as last amended by Regulation (EEC) No 456/74⁽⁶⁾, laid down detailed rules of application for Regulation (EEC) No 1569/72; whereas the components used to calculate

the differential amounts are fixed by Regulation (EEC) No 451/74⁽⁷⁾, as last amended by Regulation (EEC) No 1168/74⁽⁸⁾; whereas the difference in accordance with Article 2 (1) of Regulation (EEC) No 1569/72 for the pound sterling for the period 8 to 14 May 1974 departs by at least 1 point from the percentage used for the previous fixing; whereas this fact should be taken into account when the components used to calculate the differential amounts for colza and rape seed are fixed,

HAS ADOPTED THIS REGULATION:

Article 1

The Annex to amended Regulation (EEC) No 451/74 is replaced by the Annex to this Regulation.

Article 2

This Regulation shall enter into force on 20 May 1974.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
