

REGULATION (EEC) No 2073/74 OF THE COMMISSION

of 5 August 1974

concerning the sale at prices fixed in advance at a standard rate of beef and veal held by intervention agencies

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation (EEC) No 805/68⁽¹⁾ of 27 June 1968 on the common organization of the market in beef and veal, as last amended by Regulation (EEC) No 1855/74⁽²⁾, and in particular Article 7 (3) thereof;

Whereas Council Regulation (EEC) No 1846/74⁽³⁾ of 16 July 1974 suspended the issue of import licences and advance-fixing certificates for beef and veal, and also the application of Commission Regulation (EEC) No 1790/74⁽⁴⁾ of 9 July 1974 linking the importation of beef and veal to the sale of meat held by the intervention agencies; provision should therefore be made to suspend, for the duration of the period during which Regulation (EEC) No 1846/74 is to apply, the provisions whereby a contract of sale is to give entitlement to an import licence;

Whereas experience has shown that, particularly in a situation such as that which obtains at present on the market in beef and veal, provision should be made to derogate from the provisions concerning the payment for and removal of the goods laid down in Article 5 (1) of Commission Regulation (EEC) No 216/69⁽⁵⁾ of 4 February 1969 on detailed rules of application for the disposal of frozen beef and veal bought in by intervention agencies;

Whereas the provisions of this Regulation replace those of Commission Regulation (EEC) No 1162/74⁽⁶⁾ of 8 May 1974 concerning the sale of beef and veal held by intervention agencies at prices fixed in advance at a standard rate, as last amended by Regulation (EEC) No 1710/74⁽⁷⁾; whereas that Regulation should therefore be repealed;

Whereas the measures provided for in this Regulation are in accordance with the Opinion of the Management Committee for Beef and Veal,

HAS ADOPTED THIS REGULATION:

Article 1

1. There shall be put up for sale, at prices fixed in advance at a standard rate, frozen beef and veal taken over before 1 July 1974⁽⁸⁾ by intervention agencies.
2. The products, cuts and selling prices shall be as set out in the Annex hereto.
3. By way of derogation from the first sentence of Article 5 (1) of Regulation (EEC) No 216/69, the price shall be paid as when the goods are removed from store, in proportion to the quantities removed and not later than the day before each removal.
4. By way of derogation from the second sentence of Article 5 (1) of Regulation (EEC) No 216/69, delivery shall be taken of the goods within eight weeks following acceptance of the bid by the intervention agency.

Article 2

Contracts of sale concluded while Regulation (EEC) No 1846/74 is in force shall not entitle the person concerned to make the linked purchase provided for in Regulation (EEC) No 1790/74.

Article 3

Contracts of sale concluded after Regulation (EEC) No 1846/74 has ceased to apply shall contain a provision giving entitlement to an import licence as provided in Regulation (EEC) No 1790/74.

Article 4

Regulation (EEC) No 1162/74 is hereby repealed.

Article 5

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.
