

**REGULATION (EEC) No 2017/75 OF THE COMMISSION**  
**of 1 August 1975**  
**fixing the import levies on olive oil**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community;

Having regard to Council Regulation No 136/66/EEC<sup>(1)</sup> of 22 September 1966 on the establishment of a common organization of the market in oils and fats, as last amended by Regulation (EEC) No 1707/73<sup>(2)</sup>, and in particular Article 13 (4) thereof;

Having regard to Council Regulation No 162/66/EEC<sup>(3)</sup> of 27 October 1966 on trade in oils and fats between the Community and Greece, and in particular Articles 3 (4) and 9 thereof;

Having regard to Council Regulation (EEC) No 443/72<sup>(4)</sup> of 29 February 1972 on the levies on refined olive oil and on certain products containing olive oil, and in particular Article 9 thereof;

Having regard to Council Regulation (EEC) No 1912/74<sup>(5)</sup> of 22 July 1974 on imports of olive oil from Tunisia, and in particular Article 5 thereof;

Having regard to Council Regulation (EEC) No 303/74<sup>(6)</sup> of 4 February 1974 on imports of olive oil from Morocco, and in particular Article 5 thereof;

Whereas the levies on olive oil were fixed by Commission Regulation (EEC) No 1621/75<sup>(7)</sup>, as last amended by Regulation (EEC) No 1923/75<sup>(8)</sup>;

Whereas it follows from applying the rules and other provisions contained in Regulation (EEC) No 1621/75 to the offer prices known to the Commission that levies at present in force should be altered as shown in the Table annexed to this Regulation,

HAS ADOPTED THIS REGULATION:

*Article 1*

The import levies referred to in Article 13 of Regulation No 136/66/EEC, Article 3 of Regulation No 162/66/EEC, Article 9 of Regulation (EEC) No 443/72, Article 5 of Regulation (EEC) No 1912/74 and Article 5 of Regulation (EEC) No 303/74 are hereby fixed as shown in the Table annexed to this Regulation.

*Article 2*

This Regulation shall enter into force on 4 August 1975.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
