

COMMISSION REGULATION (EEC) No 84/79

of 17 January 1979

concerning the third amendment to Regulation (EEC) No 1557/78 on the sale at a price fixed at a standard rate in advance of preserved beef held by the intervention agencies

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal ⁽¹⁾, as last amended by Regulation (EEC) No 425/77 ⁽²⁾, and in particular Article 7 (3) thereof,

Whereas Annex I to Commission Regulation (EEC) No 1557/78 ⁽³⁾, as last amended by Regulation (EEC) No 2868/78 ⁽⁴⁾, lays down *inter alia* the selling prices of preserved beef held by the Danish intervention agency and intended for export;

Whereas it has been impossible to sell the quantities offered for sale at these prices; whereas, therefore, it seems necessary to reduce them;

Whereas it is appropriate to provide for a better division of the meat concerned in cases where the quantities available are limited, thereby avoiding discouraging interested persons who may be unable to submit their offers in time;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Beef and Veal,

HAS ADOPTED THIS REGULATION:

Article 1

Annex I to Regulation (EEC) No 1557/78 is replaced by the Annex to this Regulation.

Article 2

If the quantities available at an intervention agency are less than those in respect of which applications to purchase are submitted on the day of entry into force of this Regulation, these applications shall be considered as having been submitted at the same time.

Article 3

This Regulation shall enter into force on 22 January 1979.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
