COMMISSION REGULATION (EEC) No 2610/79

of 26 November 1979

fixing the import levies on frozen beef and veal

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 805/68 of 27 June 1968 on the common organization of the market in beef and veal (1), as last amended by Regulation (EEC) No 425/77 (2), and in particular Article 12 (8) thereof,

Whereas the import levies on frozen beef and veal were fixed by Regulation (EEC) No 1366/79 (3), as last amended by Regulation (EEC) No 2363/79 (4);

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 1366/79 to the

quotations and other information known to the Commission, that the levies should be set out in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies on frozen beef and veal shall be as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 3 December 1979.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
