

COMMISSION DECISION

of 6 October 1980

authorizing the Kingdom of Denmark not to apply Community treatment to men's and boys' shirts, woven, originating in South Korea

(Only the Danish text is authentic)

(80/1015/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community, and in particular the first paragraph of Article 115 thereof,

Having regard to Commission Decision 80/47/EEC of 20 December 1979 on surveillance and protective measures which Member States may be authorized to take in respect of imports of certain products originating in third countries and put into free circulation in another Member State ⁽¹⁾, and in particular Article 3 thereof,

Whereas on 23 September 1980 a request was made under the first paragraph of Article 115 of the Treaty by the Kingdom of Denmark to the Commission of the European Communities for authorization not to apply Community treatment to men's and boys' shirts, woven, falling within heading No ex 61.03 of the Common Customs Tariff (category 8), originating in South Korea and in free circulation in the other Member States,

Whereas the importation into the Community of the products in question, originating in South Korea, is covered by an Agreement negotiated between the Community and that country;

Whereas, under that Agreement, South Korea has undertaken to take all necessary steps to limit its exports of the products in question to the Community to within certain ceilings;

Whereas in order to implement that Agreement and take account of its characteristics, the Council adopted Regulation (EEC) No 3059/78 ⁽²⁾, as last amended by Commission Regulation (EEC) No 3063/79 ⁽³⁾, introducing specific common rules for imports of certain textile products;

Whereas the differences in market conditions within the Community and the particular sensitivity of this branch of Community industry have been taken into

account in allocating the abovementioned Community ceilings between the Member States;

Whereas for this reason disparities still exist between the conditions governing the importation of the products in question into the different Member States; whereas uniformity can only be brought about gradually;

Whereas these disparities in the commercial policy measures applied by the Member States have resulted in deflections of trade, in that since 1 January 1980 Denmark has admitted the products in question in free circulation, of which 120 000 pieces originated in the said third country;

Whereas the information received by the Commission indicates that the direct quota of the products in question, originating in South Korea, has been taken up for 100 %;

Whereas total imports of the products in question, originating in third countries have increased from 6 465 000 pieces in 1978 to 6 711 000 pieces in 1979;

Whereas the prices of the products in question, originating in South Korea are approximately 40 % below the prices of like products manufactured in Denmark;

Whereas the domestic industry's share of the home market has remained at a level of 6 %;

Whereas further indirect imports, in addition to those already admitted or planned, would be likely to aggravate these difficulties and jeopardize the aims of the abovementioned commercial policy measures;

Whereas it is not possible to set in motion rapidly the machinery for bringing about the necessary cooperation from the other Member States;

Whereas authorization should accordingly be given for the application of protective measures under the first paragraph of Article 115, subject to the conditions laid down in Decision 80/47/EEC, and in particular Article 3 thereof,

HAS ADOPTED THIS DECISION :

Article 2

Article 1

The Kingdom of Denmark is authorized not to apply Community treatment to the products indicated below, originating in South Korea and in free circulation in the other Member States, in respect of which applications for import licences were lodged after the date of the adoption of this Decision :

This Decision shall apply until new opportunities arise in Denmark for the importation of the products in question originating in South Korea or until 31 December 1980, whichever is the earlier.

Article 3

This Decision is addressed to the Kingdom of Denmark.
