

COMMISSION REGULATION (EEC) No 1118/80

of 6 May 1980

re-establishing the levying of customs duties on knitted or crocheted fabric, products of category 63 (code 0630), originating in India, to which the preferential tariff arrangements set out in Council Regulation (EEC) No 2894/79 apply

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 2894/79 of 10 December 1979 opening, allocating and providing for the administration of Community tariff preferences for textile products originating in developing countries and territories⁽¹⁾, and in particular Article 5 thereof,

Whereas Article 3 (1) of that Regulation provides that customs duties may, for each category of products, be suspended up to a Community ceiling which is indicated in column 6 of Annex B, for each of the beneficiaries indicated in column 5 of the same Annex;

Whereas Article 4 (1) of that Regulation provides that the levying of customs duties may be re-established at any time in respect of imports of the products in question originating in any of the said countries and territories, once the relevant Community ceiling has been reached;

Whereas, in respect of knitted or crocheted fabric, products of category 63, the ceiling should be two tonnes; whereas on 28 April 1980 the amounts of imports into the Community of knitted or crocheted fabric, products of category 63, originating in India, a country covered by preferential tariff arrangements, reached that ceiling; whereas, bearing in mind the objectives of Regulation (EEC) No 2894/79 which provides that the ceiling should not be exceeded, customs duties should be re-established in respect of the products in question in relation to India,

HAS ADOPTED THIS REGULATION :

Article 1

As from 10 May 1980, the levying of customs duties, suspended in pursuance of Council Regulation (EEC) No 2894/79, shall be re-established in respect of the following products, imported into the Community and originating in India :

Article 2

This Regulation shall enter into force on the third day following its publication in the *Official Journal of the European Communities*.
