COMMISSION REGULATION (EEC) No 223/81

of 29 January 1981

altering the components used to calculate the differential amounts for colza and rape seed

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation No 136/66/EEC of 22 September 1966 on the establishment of a common organization of the market in oils and fats (1), as last amended by Regulation (EEC) No 3454/80 (²),

Having regard to Commission Regulation (EEC) No 878/77 of 26 April 1977 on the exchange rates to be applied in agriculture (3), as last amended by Regulation (EEC) No 3447/80 (4),

regard to Council Regulation (EEC) No 1569/72 of 20 July 1972 laying down special measures for colza and rape seed (5), as last amended by Regulation (EEC) No 852/78 (6), and in particular Article 3 thereof,

Whereas Commission Regulation (EEC) No 2300/73 of 23 August 1973 (7), as last amended by Regulation (EEC) No 1162/80 (8), laid down detailed rules of application for Regulation (EEC) No 1569/72; whereas the components used to calculate the differential amounts were fixed by Regulation (EEC) No 1690/80 (9), as last amended by Regulation (EEC) No 173/81 (10); whereas, in the case of the pound sterling and the Greek drachma, the difference referred to in Article 2 (1) of Regulation (EEC) No 1569/72 for the period 21 to 27 January 1981 has changed, by reference to the representative rate valid on 2 February 1981, by at least one point from the percentage used for the previous fixing; whereas this fact should be taken into account when fixing the components used to calculate the differential amounts for colza and rape seed where those components are already applied in respect of the Member States concerned,

HAS ADOPTED THIS REGULATION:

Article 1

The Annex to Regulation (EEC) No 1690/80 is hereby replaced by the Annex hereto.

Article 2

This Regulation shall enter into force on 2 February 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
