

COMMISSION DECISION

of 5 March 1984

fixing maximum amounts for contracts awarded under the tendering procedure opened by Regulation (EEC) No 359/84 on the supply of various lots of butteroil as food aid

(84/137/EEC)

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

HAS ADOPTED THIS DECISION:

Article 1

Having regard to the Treaty establishing the European Economic Community,

The maximum amounts to be adhered to when awards are made under the tendering procedure opened by Regulation (EEC) No 359/84 shall be:

Having regard to Council Regulation (EEC) No 804/68 of 27 June 1968 on the common organization of the market in milk and milk products⁽¹⁾, as last amended by Regulation (EEC) No 1600/83⁽²⁾, and in particular Article 6 (7) thereof,

Whereas, under Commission Regulation (EEC) No 359/84 of 10 February 1984 on the supply of various lots of butteroil as food aid⁽³⁾, tenders have been invited for the supply of 7 725 tonnes of butteroil to certain third countries and certain organizations;

Whereas Article 13 (1) of Commission Regulation (EEC) No 1354/83 of 17 May 1983 laying down general rules for the mobilization and supply of skimmed-milk powder, butter and butteroil as food aid⁽⁴⁾, as amended by Regulation (EEC) No 1886/83⁽⁵⁾, specifies that in the light of the tenders received a maximum amount shall be fixed for each lot, or part thereof if the third subparagraph of Article 11 (3) is used, or a decision shall be taken to make no award;

In the case of lots C and G no award shall be made.

Article 2

This Decision is addressed to the Member States.

Whereas on the basis of the tenders received the maximum amounts should be those specified below;
