COMMISSION REGULATION (EEC) No 516/86

of 27 February 1986

fixing the import levies on live sheep and goats and on sheepmeat and goatmeat other than frozen meat

THE COMMISSION OF THE EUROPEAN COMMUNITIES.

Having regard to the Treaty establishing the European Economic Community,

Having regard to Council Regulation (EEC) No 1837/80 of 27 June 1980 on the common organization of the market in sheepmeat and goatmeat (1), as last amended by Regulation (EEC) No 3768/85 (2), and in particular the first paragraph of Article 11 thereof,

Whereas the import levies on live sheep and goats and on sheepmeat and goatmeat other than frozen meat were fixed by Regulation (EEC) No 3648/85 (3), as amended by Regulation (EEC) No 161/86 (4);

Whereas it follows from applying the detailed rules contained in Regulation (EEC) No 3648/85 amended to the quotations and other information known to the Commission that the levies at present in force should be altered to the amounts set out in the Annex hereto;

Whereas, pursuant to Article 394 of the Act of Accession of Spain and Portugal, the application to the new Member States of the Community rules introduced for the production of and trade in agricultural products and for the trade in certain goods resulting from the processing of agricultural products shall be postponed,

HAS ADOPTED THIS REGULATION:

Article 1

The import levies on live sheep and goats and on sheepmeat and goatmeat other than frozen meat shall be as set out in the Annex hereto.

Article 2

This Regulation shall enter into force on 3 March 1986.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
