COMMISSION REGULATION (EEC) No 1951/88

of 1 July 1988

altering the export refunds on syrups and certain other sugar sector products exported in the natural state

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Spain and Portugal,

Having regard to Council Regulation (EEC) No 1785/81 of 18 June 1981 on the common organization of the markets in the sugar sector (1), as last amended by Regulation (EEC) No 3993/87 (2), and in particular Article 19 (4) thereof,

Whereas the refunds on syrups and certain other sugar products were fixed by Regulation (EEC) No 1878/88 (3);

Whereas it follows from applying the rules, criteria and other provisions contained in Regulation (EEC) No

1878/88 to the information at present available to the Commission that the export refunds at present in force should be altered as shown in the Annex hereto,

HAS ADOPTED THIS REGULATION:

Article 1

The refunds to be granted on the products listed in Article 1 (1) (d), (f) and (g) of Regulation (EEC) No 1785/81, exported in the natural state, as fixed in the Annex to Regulation (EEC) No 1878/88 are hereby altered to the amounts shown in the Annex hereto.

Article 2

This Regulation shall enter into force on 2 July 1988.

This Regulation shall be binding in its entirety and directly applicable in all Member States
