COMMISSION REGULATION (EC) No 2981/94

of 7 December 1994

amending Regulations (EC) No 953/94, (EC) No 1077/94, (EC) No 1078/94, (EC) No 1079/94, (EC) No 1080/94, (EC) No 2162/94 and (EC) No 2477/94 opening standing invitations to tender for the export of cereals held by the intervention agencies

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Community,

Having regard to Council Regulation (EEC) No 1766/92 of 30 June 1992 on the common organization of the market in cereals (1), as last amended by Regulation (EC) No 1866/94 (2), and in particular Article 5 thereof,

Whereas Commission Regulation (EEC) No 2131/93 (3), as amended by Regulation (EC) No 120/94 (4), lays down the procedures and conditions for the disposal of cereals held by the intervention agencies;

Whereas the last partial invitation to tender under Commission Regulations (EC) No 953/94 (°), as last amended by Regulation (EC) No 2734/94 (°), (EC) No 1077/94 (7), as last amended by Regulation (EC) No 2229/94 (8), (EC) No 1078/94 (9), as last amended by Regulation (EC) No 1819/94 (10), (EC) No 1072/94 (11), as last amended by Regulation (EC) No 2451/94 (12), (EC) No 1080/94 (13), as amended by Regulation (EC) No 1689/94 (14), (EC) No 2162/94 (15), as last amended by Regula-

tion (EC) No 2734/94, and (EC) No 2477/94 (16), as amended by Regulation (EC) No 2734/94 should be postponed;

Whereas the measures provided for in this Regulation are in accordance with the opinion of the Management Committee for Cereals,

HAS ADOPTED THIS REGULATION:

Article 1

In Article 4 (3) of Regulations (EC) No 953/94, (EC) No 1077/94, (EC) No 1078/94, (EC) No 1079/94, (EC) No 1080/94, (EC) No 2162/94 and (EC) No 2477/94, '22 December 1994' is replaced by '18 May 1995'.

Article 2

This Regulation shall enter into force on the day of its publication in the Official Journal of the European Communities.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
